BID BOND

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, Coastal Bridge Company, LLC as PRINCIPAL, and Arch Insurance Company _____ as SURETY, are hereby held and firmly bound unto _____ West Baton Rouge Parish Government _____ as OWNER in the penal sum of five percent of the amount bid (5%) _____ for the payment of which, well and truly to be made, we hereby jointly and severally bind ourselves, successors and assigns. Signed, this 8th day of May, 2014.

The condition of the above obligation is such that whereas the PRINCIPAL has submitted to _____ West Baton Rouge Parish Government _____ a certain BID, attached hereto and hereby made a part hereof to enter into a CONTRACT in writing, for 2014 Road Maintenance Program.

NOW, THEREFORE,

- (a) If said BID shall be rejected, or


