### **Section 1.0 – Pre-Bid Conference:**

There will be no pre-bid conference for this bid. All bidders are encouraged to visit the site prior to submitting a bid.

### **Section 2.0 – Scope:**

We extend this bid to provide insurance, labor, materials, delivery, equipment, transportation, fuel, and all other incidentals necessary to provide and install trees at Woodland West Park located at 2143 Mars Street in Harvey, Louisiana for the Jefferson Parish Parkways Department (Parkways).

### **Section 3.0 – Bid Bond:**

There is no bid bond required for this bid submission.

### **Section 4.0 – Performance Bond:**

There is no performance bond required for this bid submission.

### **Section 5.0 – Payment Bond:**

There is no payment bond required for this bid submission.

### **Section 6.0 – Site Location:**

The site is located at 2143 Mars Street, Harvey, Louisiana 70058. The playground is open from 6:00 am to 8:00 pm Monday thru Sunday. Parish holidays may affect these times.

### **Section 7.0 – License:**

Bidders shall be licensed per LSA-R.S. 37:2150-2163 and shall furnish copies of the front and back (if applicable) of each required license. Failure to submit these copies will deem the bid non-responsive.

#### **Bidders and/or any applicable subcontractor(s) shall possess the following licenses:**

- Louisiana State Contractor's Commercial license with the classification of SUBCLASSIFICATION: LANDSCAPE, GRADING AND BEAUTIFICATION. This license number is to be located on the electronic envelope.

### **Section 8.0 – Regulations:**

The Contractor is solely responsible to adhere to any and all regulations and guidelines set forth by all local, state and federal agencies.

### **Section 9.0 – Term of Contract:**

Once the Notice to Proceed is issued, the Contractor shall have thirty (30) calendar days to complete the installation.

### **Section 12.0 – Subcontractors:**

The use of sub-contractors shall be allowed to fulfill the requirements of this contract. The Contractor shall be fully responsible for the actions of any sub-contractors. Parkway must be made aware whenever a subcontractor is scheduled to be working at the site.

### **Section 13.0 – Bid Specifications:**

Refer to the attached plans for species and the proposed layout of the trees to be planted. All trees shall be field marked by the Parkway Department prior to the Contractor planting any trees. Each tree species shall be uniform in size and appearance. All trees shall be container grown nursery stock

All planting shall be in accordance with the tree planting detail located on the plans. The Contractor shall be responsible for locating all utilities prior to beginning his work.

As needed, the Contractor may utilize the parking lot for staging and deliveries. The Parkways Department will provide the exact location for staging. Jefferson Parish is not responsible for securing any staging areas.

The Contractor shall be responsible for acquiring all materials and equipment necessary for his tree planting operations. The Contractor shall be responsible to irrigating the trees during and immediately after installation. The Contractor shall be allowed to utilize the park's water supply for his irrigation activities. The Contractor shall be responsible to irrigate the trees, as needed, for thirty (30) calendar days from the date of Substantial Completion.

**Section 14.0 – Warranty:**

The Contractor shall warrant all trees for the period of one (1) year from the date of Substantial Completion. The Contractor is exempt from replacing trees, after Substantial Completion and during the warranty period, that are removed by others, lost or damaged by a third party, vandalism or any natural disaster.

**Section 15.0 – Notifications:**

Once the contract is awarded, the successful bidder shall provide Parkways an anticipated schedule of work. This schedule shall include, but not be limited to, ordering and receiving of the plant material, installation schedule and maintenance schedule.

**Section 16.0 Working Hours:**

On-site work shall be performed Monday thru Friday between the hours of 6:00 a.m. thru 4:00 p.m. The Contractor must receive written approval from Parkways for any planned work outside of this typical schedule.

**Section 17.0 – Payment:**

The contract shall be paid in full once the project is complete. No partial payments shall be made for this project.

**Section 18.0 – Safety Precautions:**

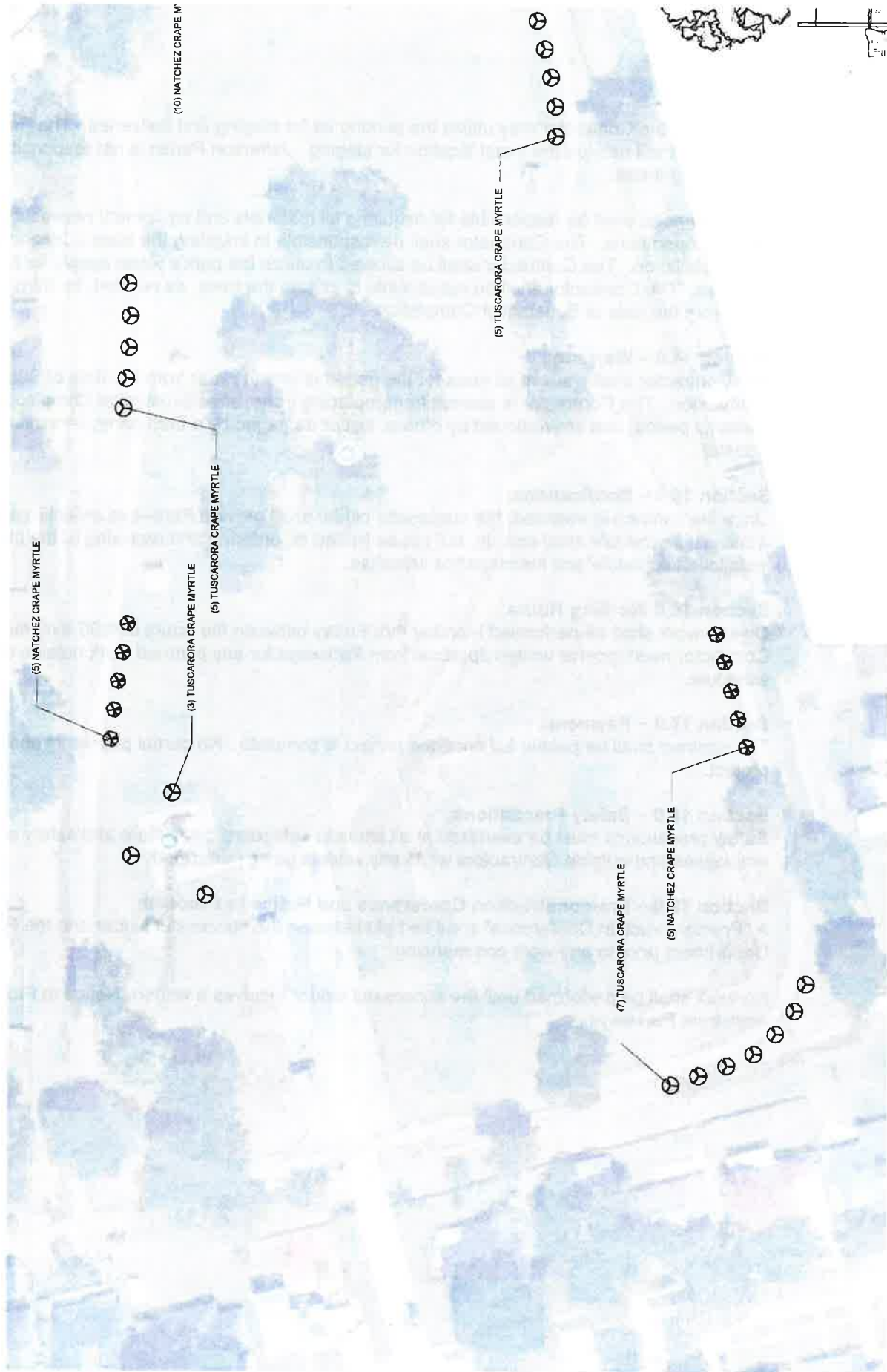
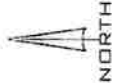
Safety precautions must be exercised at all times to safeguard the welfare and safety of citizens, parish employees and outside Contractors while any work is being performed.

**Section 19.0 – Pre-construction Conference and Notice to Proceed:**

A "Pre-construction Conference" shall be held between the successful bidder and the Parkways Department prior to any work commencing.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work from Parkways.

## **STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES**

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 136353 or No. 141125, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or her designee, with the concurrence of the Director of Risk Management or her designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. **Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.** Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.
