SECTION 2.0 – SCOPE:

The owners extend this bid to cover all labor, materials, deliver, equipment and all other essentials to install Bermuda sod in the baseball infield, the sidelines, and the back arc at Girard Playground, 5300 Irving Street, Metairie, LA 70003

SECTION 3.0 – QUANTITIES/INSPECTION:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

SECTION 4.0 – BID SPECIFICATIONS:

- Vendor will deliver and install 2,800 square yards of bid roll Bermuda in the baseball infield, the sidelines, and the back arc.

SECTION 5.0 – HOURS OF WORK:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

SECTION 6.0 – CLEANING AREA AND SAFETY:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. An umbrella policy or excess may be used to meet minimum requirements.

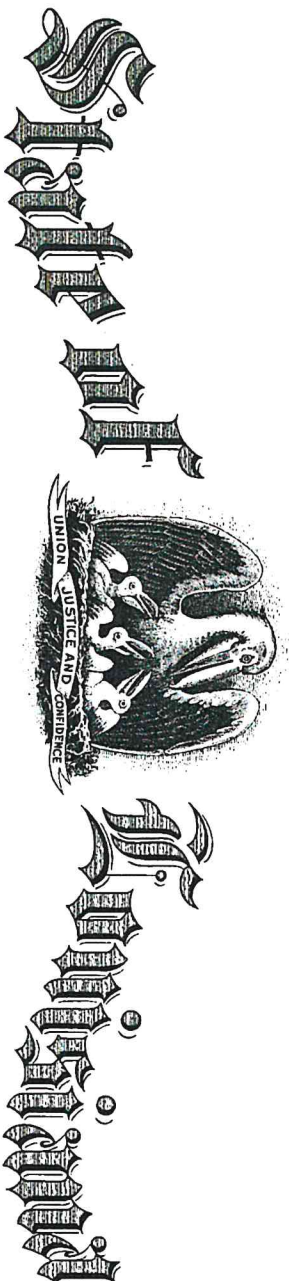
