## **RESOLUTION**

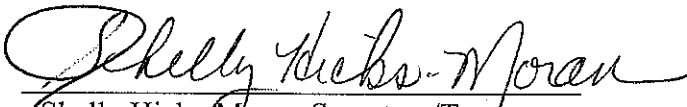

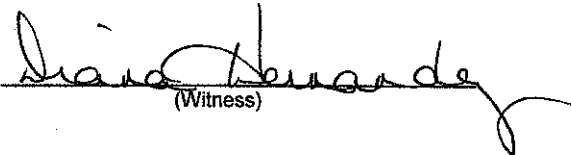
