Changes to Jefferson Parish Bidding Information

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Probable Construction Cost: Per Jefferson Parish Administrative Policy, the probable construction cost is not revealed in the Jefferson Parish Bidding Documents. Jefferson Parish Administrative Policy has changed and a range of the probable construction cost will be stated in the Jefferson Parish bidding document, entitled Important Notice to All Bidders – Bid Requirements. Per Louisiana Public Bid Law, the probable construction cost will be read at the bid opening.

In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the Mandatory pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

Section 2.0 – Scope:

We extend this bid to provide labor, materials, delivery, equipment and all other incidentals necessary to remove one (1) existing IEA™ water circuit engine cooling heat exchanger and supply and install one (1) new IEA™ water circuit engine cooling heat exchanger model: HC025S76 for generator #2 at the Jefferson Parish Emergency Operation and Communication Center located at 910 3rd Street, Gretna, LA 70053.

Section 3.0 – License Requirements:

A Louisiana State Contractor's License is required in each of the following categories:

- Commercial Contractor and
- Electrical Work (Statewide) and
- Specialty: Installation of Equipment, Machinery and Engines

A LA State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq. and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

Section 4.0 – Performance Bond:

A Performance Bond in the amount of 100% of the total contract amount will be required. Performance bond shall be produced upon contract execution.

Section 5.0 – Payment Bond:

A payment bond in the amount of 100% of the total contract amount will be required. Payment bond shall be produced upon contract execution.

Section 6.0 – Submittals:

If bidder intends to provide materials equal to or better than owner specified materials the following shall be provided with their bid:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of labor and materials and equipment required to complete this project.

Section 8.0 Demolition of Water Circuit Engine Cooling Heat Exchanger:

- Remove and properly dispose of all radiator coolant.
- Remove and properly dispose of one (1) existing IEA™ water circuit engine cooling heat exchanger Model# HC025S33.
- Remove and properly dispose of one (1) expansion take and all accessories.
- Remove and properly dispose of existing pipe insulation from water circuit engine cooling heat exchanger to isolation valves.
- Disconnect existing water piping between isolation valves and existing water circuit engine cooling heat exchanger.
- Remove and properly dispose of four (4) existing isolation valves (two on the supply line and two on the return line).
- Disconnect high voltage and control wiring from water circuit engine cooling heat exchanger.

Section 8.1 Installation of Water Circuit Engine Cooling Heat Exchanger:

- All equipment and materials shall be bidder supplied new.
- Supply and install one (1) new IEA™ water circuit engine cooling heat exchanger Model# HC025S33.
- New bidder supplied water circuit engine cooling heat exchanger shall be mounted and bolted to roof.

Section 8.1 Installation of Water Circuit Engine Cooling Heat Exchanger: Continued

- Any modifications to the roof shall be performed by a roofing company certified by The Garland Company Inc. as per the roofing manufacturer's recommendations and guidelines.
- Supply and install new hail guards.
- Supply and install one (1) new expansion tank in existing location.
- New bidder supplied expansion tank shall be mounted using new corrosion resistant isolation straps and stainless steel hardware.
- Supply and install new properly sized braided stainless steel hose lines and brass fittings from new water circuit engine cooling heat exchanger to new expansion tank.
- Supply and install four (4) new brass isolation valves on each existing supply and return line.
- Supply and install new steel supply and return pipe from new isolation valves to new water circuit engine cooling heat exchanger.
- New steel pipe shall match existing pipe size and thickness.
- All bolts, nuts, and hardware shall be 316 stainless steel.
- Supply and install new fiberglass pipe insulation from new water circuit engine cooling heat exchanger to new isolation valves on the supply and return water pipes.
- Pipe insulation shall be a minimum 2" thick.
- Install aluminum jacketing on all piping, valves, and fittings affected by this project.
- Supply and install new properly sized copper wire and EMT conduit from new bidder supplied watertight disconnect with new fuses to new water circuit engine cooling heat exchanger.
- Refill coolant system with new Cummings/Onan generator approved coolant.

Section 9.0 Commissioning:

Commissioning shall be performed by a factory authorized and trained representative of equipment manufacturer. All commissioning shall be performed with an owner's representative present and a hand written report given to owner at completion of commissioning. Seven days from completing the commissioning of the equipment a typed copy of the report shall be delivered to owner.

Section 10.0 - Hours of Work:

The work that is to be performed shall be scheduled during normal working hours 7:00 a.m. – 5:00 p.m. Monday thru Friday. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

Section 11.0 – Existing Structure:

Should any modifications to the facility be required during this project, the successful bidder shall restore the facility to its original condition, with the same type materials, finish, and workmanship.

Section 12.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris caused by this work daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Storage of flammable materials will not be permitted on the premises. All flammable materials must be removed from the job site daily. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 13.0 – Warranty:

All workmanship and materials shall have a minimum of one (1) year all parts and labor warranty. Warranty will commence on the date of acceptance of the project.

Section 14.0 – Safety Data Sheet (SDS):

The successful bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances that will be brought to and/or used at the workplace. The successful bidder shall provide SDS as per this requirement to the Director of the Jefferson Parish Department of General Services.

Section 15.0 – Liquidated Damages:

Commencing on the fourth day following the notice to proceed until work is complete, liquidated damages will be assessed in the amount of \$300 dollars per day.

Section 16.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No materials shall be ordered until the successful bidder receives a written Notice to Order Materials and no work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.
