JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. Section 2.0 – Scope:

The owners extend this bid to cover all labor, materials and necessary essentials
to upgrade 10 ton condensing unit.

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to
determine the proper quantity of materials and equipment required to complete
this project. All measurements given in these specifications are informational
only.

Section 4.0 – License Requirements:

The following Louisiana State license shall be required for this project:

- Commercial License
- Louisiana State Specialty Licenses in Mechanical Work (Statewide)

Section 5.0 – Bid Specifications:

- Contractor shall remove and dispose of existing York 10-ton outdoor unit. Recover and reclaim refrigerant from two (2) circuits as per EPA Guidelines. Reclaimed refrigerant shall not be used in new system.
- Furnish and install one (1) American Standard 10-ton dual circuit outdoor condensing unit, Model Number TTA12044Dm with the following options:
 - Phase monitor
 - Modulating outdoor condenser fan motor
 - Coil guards
 - Coated condenser coils
- Provide necessary support under unit including vibration pads on corners of equipment.
- Contractor shall isolate refrigerant line set circuits independently from indoor coil and outdoor coil. Pressurize with nitrogen at 150 psi for 48 hours in order to verify no other leaks are located in the system.
- Re-pipe outdoor condensing with ACR copper and insulate suction line with $\frac{3}{4}$ inch wall rubbertex. Furnish and install cush clamps to support copper to unistrut. Paint exposed outdoor rubbertex with UV coating.
- Replace indoor TXV's, provide new liquid line driers, sight glasses and ball valves.
- Chemically clean evaporator coil and sanitize. Replace blower belt with cog-type commercial grade belt.
- Verify design CFM's on air handling unit as per Jefferson Parish mechanical prints. Provide documentation on completion of air flow measurements including static pressure, RPM, blower motor data and transverse measurements.
- Route new electrical whip to new outdoor unit. Furnish necessary wire, fuses and materials.
- Perform system startup.

Section 6.0 – Hours of Work:

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Existing Structure:

Should any cutting, patching alteration, addition, or repairs to existing structure, wall, floor, ceiling or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish and workmanship.

Section 9.0 – Warranty:

The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner. Unit shall contain 5-year parts and labor warranty. Provide binder with warranty papers, air balance sheet and IOM upon job completion.

Section 10.0 – SDS (Safety Data Sheets):

The bidder shall notify the Jefferson Parish Department of Recreation contact person of any hazardous substances that will be bought to and/or used at the workplace.

Section 11.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcements. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

Note: If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date.
