The above referenced bid was opened on 12/19/2019. The Purchasing Department must release the bid tabulation to all responding vendors by the close of business on the 14th day following the bid opening date and the 14th day is 01/02/2020. Per Public Bid Law LA R.S. 38:2212, Purchasing may release the bid tabulation to all responding vendors prior to the 14th day following the bid opening date, if the award recommendation has been received from the department. If you determine the low bidder has not satisfied the required specifications and should be rejected, your department must make its recommendation to the Purchasing Department by the 12th day following the bid opening date, which is 12/31/2019, in order for the bid tabulation to be revised to reflect the blank resolution.

Regardless of whether the low bid is accepted or rejected, a blank resolution must be submitted to the buyer assigned to the bid. The deadline for award is 02/21/2020, which is the 45th day following bid opening. Once you have made a recommendation for award, please forward a copy of the blank resolution routed for placement on the Council agenda to Dreamey@jeffparish.net.

Pursuant to LA R.S. 38:2215 and stated within the Jefferson Parish Ordinance, Section 2-905:

All bids must be awarded or rejected within 45 calendar days following the date of bid opening unless both low bidder and Jefferson Parish mutually consent in writing to extend the deadline.

A copy of the signed price extension letter must be forwarded to the Buyer assigned to the bid in the Purchasing Department. A sample price extension letter is available on the Parish Intranet – Purchasing– Purchasing Bid Forms as well as in the Outlook Purchasing Public Folder.

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. DEDUCTIBLES: The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

PROTESTS: Only those vendors that submit bids in response to a solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing.
