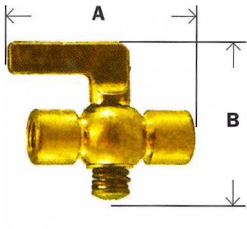

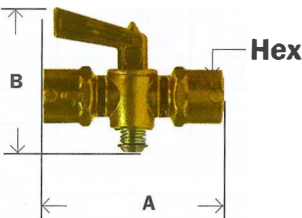
SHUT-OFF COCKS
