The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. **SPECIFICATIONS FOR NEW MECO SHADES
AT THE EDITH S. LAWSON LIBRARY
IN WESTWEGO**

Section 1.0 Scope:

We extend this bid to provide labor, materials, delivery, equipment, and all other incidentals necessary to install twenty-three (23) new Mecho Shades at The Edith S. Lawson Library, located at 635 Fourth Street, Westwego, Louisiana 70094, for the Library Department.

The person to contact concerning this bid is Offord Langston, Library Property Manager. He can be reached at 504/838-1100, Ext. 2902, between the hours of 8:00 a.m. and 3:00 p.m., Tuesday through Friday.

Section 2.0 Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project.

Section 3.0 Bid Specifications

The successful Bidder shall furnish all necessary labor, materials, equipment, and shipping necessary to install twenty-three (23) new Mecho Shades as per the following:

- Twenty-two (22) Exterior Windows Mecho Shades Fabric Series @ 1% Openness Factor Fabric Color #1112 Charcoal includes Wall Mount Brackets, Fascia and End Caps as needed.
- One (1) Interior Window Mecho Shade V Fabric Series 1612 Color Charcoal includes Wall Mount Brackets, Fascia and End Caps as needed.
- Installation: Twenty-three (23) Various Interior and Exterior Windows
- Removal/Installation: Take down existing shades and discard product.
- Two (2) Minimum Trip Allowances

Section 4.0 Removal and Installation

The removal and installations shall be scheduled in advance. Installation to be done Monday through Friday, between the hours of 8:00 a.m. and 4:00 p.m.

Section 5.0 Cleaning Area and Safety:

Job site must be kept clean and free of all litter and debris daily, and upon completion of the contract. Passageways must be kept clean and free of wrappings, rubbish, materials, equipment, and debris at all times. Inflammable material must be removed from the job site daily, inflammable materials storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the safety and welfare of the general public, the employees of Jefferson Parish, and Parish officials, and their property. Driveways must be kept clear of supplies, equipment, and debris at all times. Trash and debris shall be cleaned-up and removed daily.

Section 6.0 Debris Removal

All project debris shall become the property of the Contractor and to be hauled away by the contractor.

Section 7.0 Security – Limited Access:

The work for this project is located at the Jefferson Parish Edith S. Lawson Library and access to and from the site will be safeguarded as such. All contractors' personnel working on this contract shall possess an identification badge with the company name, and the individuals' name. Each identification badge shall be worn in a conspicuous area of the individual's shirtfront, left side.

The contractor's employees may use the public restroom facilities for personal use only, provided they help maintain cleanliness. The cleaning of equipment or tools in lavatories or any misuse of any kind in the restroom facilities will not be tolerated. Any damages incurred by contractor's personnel shall remain the sole responsibility of the bidder.

The Bidder must consider the security and integrity of the Library before, during and after daily installation and repair and/or project work. Prevent access by the public to materials, tools, ladders, equipment, etc. during the course of this contract. Tools, equipment, materials, and miscellaneous supplies are the responsibility of the Bidder, and must be protected and secured at all times, to the satisfaction of the Owner.

Section 8.0 Product Deliver, Storage, and Handling:

Deliver only new materials in the manufacturer's original sealed and legibly labeled containers, cartons, rolls, crates, etc.

Bidder will guarantee delivery of materials in accordance with such time requirements and/or schedules as may be provided in these specifications. All destination delivery costs and charges will be included in this bid.

Section 9.0 Warranty:

The successful bidder will issue a limited lifetime warranty which will include that the hardware and shade cloths of dependable service it's shade system (interior use products) are free of manufacturing defects in factory materials or workmanship for a period not to exceed 25 years from the shipment date.

The bead chain component is a fail-safe element and is not warranted.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**.
