Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

Section 1.0 – Pre-Bid Conference: SITE VISIT

Section 2.0 – Scope:

We extend this proposal to cover all labor, materials, and necessary essentials to remove existing doors and hardware, and replace with new doors, and hardware.

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 4.0 – Bid Specifications:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at Pard Playground, 5185 Eight Arpent Rd, Marrero, La 70072

- Perform moisture test, 5 pounds per 100 square feet, to determine the moisture rating. If it is over 14, it will need (2) coats of moisture barrier at an additional cost.
- Prep floor to include adding floor filler as needed to correct any un-level areas in the concrete base floor
- Provide and lay down an approximated 16852 square feet of Burke Luxury tile LVT12-102B Blond oak or equal for the hallway, and both stairwells
- Provide and lay down an approximated 700 square feet of Burke Luxury tile LVT12-103B Dark cherry or equal for downstairs meeting room and kitchen
- Provide and install approximately 2385 square feet of 6 inch cove base for hallway, stairwells, meeting room, and kitchen. Owner will pick color after bid is awarded from a chart
- All measurements must be field verified. **All measurements provided are approximations only.**
- Provide all transitions to existing flooring at all downstairs doorways
- All work to be done in workmanlike manner.
- Also, any and all damage incurred during process of job will be contractor's responsibility.

- All workmanship shall have a (1) year warranty in writing from the date of acceptance of the project against defects

A Pre-Installation Conference shall be held between the successful bidder and the owner before any work commences.

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the bid. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

DEDUCTIBLES

No insurance required shall include a deductible not greater than \$10,000.00. The cost of the deductible shall be borne by the contractor.

NOTE: If the vendor requires a change in deductibles, the request must be submitted in writing to the Purchasing Department prior to the due date of the bid. Such request shall be reviewed by the Parish Attorney's Office with the concurrence of the Director of Risk Management.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required unless otherwise specified in the bid. Such insurance is due upon contract execution.

1) OWNER'S PROTECTIVE LIABILITY

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

2) BUILDER'S RISK INSURANCE

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
