BID #1055 – PURCHASE OF LARGE KITCHEN EQUIPMENT
GENERAL CONDITIONS & INSTRUCTIONS TO BIDDERS

1. Any item not received within sixty (60) days upon receipt of the purchase order, will be considered as an immediate default in the contract on the part of the supplier, without the necessity of a written notice to the supplier to that effect. The Board, at that point, shall be free to purchase said supplies from any other firm whether or not said supplies are eventually delivered, reserving unto itself the right to proceed for any damages or cost increases incurred as a result of the repurchase of those supplies which were to be timely delivered by supplier. Further, failure to comply could possibly lead to removal from the IPSB Bid List as an irresponsible bidder on the part of said defaulting supplier.
2. Bidder must use the enclosed bid form to designate both unit cost and the total cost of each item. ALL BIDS MUST BE SIGNED BY AN AUTHORIZED REPRESENTATIVE OF THE FIRM SUBMITTING THE BID. Please total your bid. All bids require an ink signature. Typed, printed or stamped names will not be accepted and will be reason for rejection of bid.
3. The sealed bid may contain only one bid in each envelope. Those bids delivered by an express mail service (Federal Express, Purolator courier, UPS Overnight, etc.) must contain the sealed envelope within the carrier's large packet. The mail service packet/envelope is only a carrier, and is not considered the sealed bid envelope.
4. In the event of an error on a bid form submitted, unit prices offered will prevail and totals will be adjusted if necessary.
5. Any non-resident firms which are awarded an order will be required to furnish a statement to the effect that all taxes duly assessed and due to the State of Louisiana and Iberia Parish have been paid.
6. All merchandise deliveries for Large Kitchen Equipment must be F.O.B. to Destinations listed within bid.
7. The School Board reserves the right to disqualify any bid as unresponsive. In addition thereto, the Board reserves the right to reject any and all bids that exceed the budgeted amount for this procurement.
8. Please use the self-addressed envelope enclosed with the appropriate labels to submit your bid. This is necessary to assure that your bid is opened at the appropriate time.
9. If bidder is unable to use the enclosed envelope, all bidders shall address plain envelopes to the IPSB, P.O. Box 200, New Iberia, LA 70562-0200, plainly marked "Bid #1055 – Large Kitchen Equipment", due May 31, 2016, and to the attention of David Delahoussaye, Purchasing Agent. ANY BIDS NOT CLEARLY MARKED WILL NOT BE ACCEPTED. Official Bid Documents are also available and may be submitted online at www.centralbidding.com.
10. The bidding body must exhibit that it is authorized to do so and is doing business in the State of Louisiana and must provide proof of all necessary licenses, assurance and bonds that are required by the State of Louisiana.
11. IF BIDDER IS AWARDED PART OR ALL OF BID, PURCHASE ORDER NUMBERS MUST BE ON ALL PACKAGES. ALL ITEMS ARE TO BE MARKED WITH ITEM NUMBER ON ALL PACKAGES.
12. Information on the awarding of bids may be obtained from the Purchasing Dept., or by attending School Board meetings, or through the official journal of the IPSB (The Daily Iberian, 926 E. Main Street, New Iberia, LA 70560).
13. On all requests for bids and proposals for any purchase, preference will be given to materials, supplies, and provisions, produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside of the state.
14. Bidder will be held responsible for indicating where item bid does not meet requested specifications. If no indication is made and bid is awarded, vendor will be held responsible for return freight and possible additional cost of next low bid item. When such an item is identified, it will be returned at vendor's expense. The IPSB reserves the right to order from the next low bidder and to follow the conditions listed for non-delivery as shown in Item #1 above.
15. In awarding the bid, due consideration will be given to conformity with specifications, delivery terms, quality, design and construction as judged by tests and previous experience, and price. The IPSB reserves the right to conduct any tests it may deem advisable and to make all evaluations. Service to the IPSB indicated above will be a factor in making award.
