**Section 1.0 – Pre-Bid Conference:**

There will be no pre-bid conference for this bid. All prospective bidders are encouraged to visit the site prior to submitting a bid.

**Section 2.0 – Scope of Work:**

This project shall include minor grading and site work, concrete work and landscape work. The bid shall cover all labor, materials, freight and necessary incidentals to perform the work in accordance with the associated plans. All work shall take place within the center median of Carol Sue Avenue in the vicinity of Heritage Avenue and Wright Avenue. Refer to the plans for a location map of the project site.

**Section 3.0 – License Requirements:**

The following Louisiana State license shall be required for this project:

- Class: Building Construction  
or
- Sub-Category: Landscape, Grading and Beautification

**Section 4.0 – Unit Pricing:**

The project shall bid as a Lump Sum price that includes some quantified line items with unit pricing. The bid includes an anticipated quantity for each line item. All final quantities shall be field verified by Jefferson Parish Parkways. The final contract price may increase or decrease based on the final measured quantities.

**Section 5.0 – Schedule:**

The Contractor shall have forty (40) calendar days from the Notice to Proceed date to reach substantial completion. Once substantial completion is approved, the Contractor will then have a maximum of thirty (30) calendar days to complete any punch list items and receive final completion. Failure to reach substantial and/or final completion within the given time may result in liquidated damages.

**Section 6.0 – Liquidated Damages:**

The Contractor may be assessed liquidated damages in the following amounts:

- \$250.00 per calendar day for each consecutive calendar day after the agreed date of substantial completion that work remains substantially incomplete.
- \$250.00 per calendar day for each consecutive calendar day after the agreed date of final completion that work remains finally incomplete.

**Section 7.0 – Existing Site:**

The existing site is easily accessible to all prospective bidders. All prospective bidders are encouraged to visit the site prior to the pre-bid conference.

**Section 8.0 - Hours of Work:**

Work shall be performed during non-holiday weekdays between the hours of 7:00 am and 4:00 pm. The Contractor shall provide the Jefferson Parish Parkways Department with a minimum twenty four (24) notice prior to the start of work. Once the installation is complete, the Contractor shall contact the Jefferson Parish Parkways Department to schedule a final inspection of the work.

**Section 9.0 – Cleaning Area and Safety:**

The job site must be clean and free of all litter and debris daily and upon completion of the contract. The Contractor shall ensure that the site is secure when he is not present. This includes, but may not be limited to, fencing and or removing equipment and materials that may pose safety issues. Safely stored equipment and material is permissible within the project site as long as all vehicular sight lines are not obstructed. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish and other Parish officials.

**Section 10.0 – Warranty:**

The Contractor shall warrant his materials and workmanship for a period of one (1) year after final acceptance of the project.

**Section 11.0 – Pre-Construction Meeting and Notice to Proceed:**








② LOCATION MAP




① PARTIAL IMPROVEMENTS PLAN




① TYPICAL SECTION FOR NEW CURB




