**PART 1 GENERAL**

**1.1 DESCRIPTION**

The bidder shall quote on furnishing one (1) Vaughan Model SP6K, or approved equal, self-priming horizontal direct drive chopper pump, and all appurtenances as specified in this section. Pump shall include impeller and upper cutter, cutter and cutter nose, bearing housing, flush less mechanical seal, 6" suction and 6" discharge, 6" suction flanges, base fabricated steel base. The pump should be specifically designed to pump waste solids at heavy consistency without clogging or dewatering solids. Materials shall be chopped and conditioned by the pump as an integral part of the pumping action. The pump must have demonstrated the ability to chop through and pump high concentrations of solids such as plastics, heavy rags, grease and hair balls, wood, paper products and stringy materials without clogging, both in tests and field applications. The pump shall be provided by an authorized factory representative for Jefferson Parish, Louisiana and for the brand being offered. Any bids submitted for pump manufacturers, other than as specified, must include in their bid all information needed to fully demonstrate complete compliance with the requirements of this specification and dimensional duplicity of the existing pump. The bid will be awarded to the lowest responsible bidder complying with all provisions of this invitation, providing the bid is reasonable, and in the best interest of Jefferson Parish. Jefferson Parish reserves the right to accept or reject the bid, any bids that are incomplete or do not provide the required information in order to show compliance with the specifications. It is the bidder's responsibility to provide adequate information necessary for the complete evaluation of proposed equipment at the time of bid. Jefferson Parish shall be the sole judge as to the equality of any alternate manufacturer's offering.

**1.2 QUALITY ASSURANCE AND PERFORMANCE AFFIDAVIT**

The contractor shall submit the manufacturer's standard warranty and a performance affidavit for equipment to be furnished in accordance with this section. The warranty for workmanship and materials shall be the manufacturer's standard for one (1) year from startup, not to exceed eighteen (18) months from factory shipment. In the performance affidavit, the manufacturer must certify to the Owner, that the Contract Documents have been examined, and that the equipment will meet in every way the performance requirements set forth in the Contract Documents for the application specified. Shop drawings will not be reviewed prior to the receipt by the Department of Sewerage of an acceptable performance affidavit. The performance affidavit must be signed by an officer of the company manufacturing the equipment and witnessed by a notary public. The performance affidavit must include a statement that the equipment will not clog or bind on solids typically found in the application set forth.

The bidder shall be the Authorized Distributor and Authorized Factory Service Center of the proposed product and shall be capable of servicing the product with repair service and parts availability within one (1) hour travel time of Jefferson Parish. The bidder must own and operate a direct factory service center and stocking facility capable of completely servicing and supplying spare parts for the proposed pump within one (1) hour travel time of Jefferson Parish. The bidder's service center must have full-time, factory-trained mechanics capable of and certified to service the proposed equipment.

## **PART 2 PRODUCTS**

### **2.1 MANUFACTURER**

- A. The pump shall be Model SP6K *self-priming* chopper as manufactured by Vaughan Co., Inc. or approved equal.
- B. It is the express intent of these specifications to accurately describe equipment that is a regular production item of the specified manufacturer, and that has a proven record of performance in identical (not just similar) applications in other treatment facilities. The chopper pump manufacturer shall have a minimum of twenty (20) years of documented experience in the design and production of chopper pumps of all types, and not less than five (5) years of experience in the production of the exact equipment as specified herein.

### **2.2 SERVICE CONDITIONS**

The pumps specified in this section will pump sludge using the following design criteria: 6" suction  
6" discharge: 25 HP: 1750 RPM 230/460/3/60 premium efficient motor.

### **2.3 PUMP CONSTRUCTION**

- A. Casing and Backplate: Pump casing shall be of volute self-priming design, spiraling outward to the ANSI CL 125 flanged centerline discharge. The back pull-out design shall incorporate adjusting sleeves for accurate adjustment of impeller-to-cutter bar clearance and shall allow removal of pump components without requiring disconnection of casing from inlet or discharge piping. The casing and backplate shall be cast ductile iron with all water passages to be smooth, and free of blowholes and imperfections for good flow characteristics. A pressure tap shall be included on or near the discharged flange. The backplate shall include a replaceable Rockwell C60 steel cutter adjustable for 0.005-0.050" clearance to cut against the rotating impeller pump-out vanes for removing fiber and debris.
- B. Impeller: Shall be semi-open type with pump out vanes to reduce seal area pressure. Chopping of materials shall be accomplished by the action of the cupped and sharpened leading edges of the impeller blades moving across the cutter bar at the intake openings, with a set clearance between the impeller and cutter bar of 0.015-0.025" cold. Impeller shall be cast alloy steel heat treated to minimum Rockwell C60 and dynamically balanced. The impeller shall be keyed to the shaft and shall have no axial adjustments and no set screws. Pumps with open type impellers or impellers without modified pump out vanes to shear against the upper cutter shall not be acceptable.
- C. Cutter Bar: Shall be recessed into the pump bowl and shall contain at least 2 shear bars

extending diametrically across the intake opening to within 0.010-0.030" of the rotating cutter nut tooth, for the purpose of preventing intake opening blockage and wrapping of debris at the shaft area. The cutter bar shall be cast steel heat-treated to a minimum Rockwell C60. Chopper pumps utilizing individually mounted shear bars shall not be acceptable.

- D. Cutter Nut: The impeller shall be secured to the shaft using a cutter nut, designed to cut stringy materials and prevent binding using a raised, rotating cutter tooth. The cutter nut shall be cast alloy steel heat treated to minimum Rockwell C60. Chopper pumps which do not have the ability to cut debris from the pump suction shall not be acceptable.
- E. Upper Cutter: Shall be threaded into the backplate behind the impeller, designed to cut against the pump-out vanes and the impeller hub, reducing and removing stringy materials from the mechanical seal area. The upper cutter shall be cast steel heat treated to minimum Rockwell C60. The upper cutter teeth are positioned as closely as possible to the center of shaft rotation to minimize cutting torque and nuisance motor tripping. The ratio of upper cutter cutting diameter to shaft diameter in the upper cutter area of the pump shall be 3.0 or less.
- F. Pump Shafting: The pump shaft and impeller shall be supported by rolling element bearings. Shaft shall be heat treated alloy steel.
- G. Bearings: Shall be oil-bath lubricated with ISO 46 hydraulic oil. Shaft thrust in both directions shall be taken up by angular contact ball bearings, or tapered roller bearings, mounted in an adjustable position thrust bearing cartridge to permit upper cutter to impeller adjustment. Two adjacently mounted ball bearings or a cylindrical roller bearing shall also be provided for radial loads. L-10 bearing life shall be minimum 100,000 hours.
- H. Bearing Housing: Shall be cast ductile iron and machined with piloted bearing fits for concentricity of all components. Bearing housing shall include a side-mounted sight glass. Bronze non-contacting labyrinth style, O-ring mount bearing isolators shall be provided at each end of the bearing housing to prevent the egress of oil and ingress of contaminants.
- I. Mechanical Seal: The mechanical seal is to be manufactured and warranted by the pump manufacturer. Pump manufacturers have at least 15 years' experience producing mechanical seals and a documented history of 10 years of installations in the same application as specified.
  - Mechanical Seal specifically designed to require no seal flush: The mechanical seal shall be located immediately behind the impeller hub to eliminate the stuffing box and maximize the flushing available from the impeller pump-out vanes. The seal shall be a cartridge-type mechanical seal with Viton O-rings and silicon carbide (or tungsten carbide) faces. This cartridge seal shall be pre-assembled, and pre-tested so that no seal settings or adjustments are required from the installer. Any springs used to push the seal faces together must be shielded from the fluid to be pumped. The cartridge shall also include a 17-4PH, heat-treated seal sleeve and stainless-steel seal housing.
- J. Inlet Manifold: Shall be cast ductile iron assembly mounted horizontally with ANSI CL 125 inlet flange, pressure tap, cleanout, drain connection and mounting feet.
- K. Shaft Coupling: Bearing housing and motor stool design is to provide accurate, self-aligning mounting for a C-flanged electric motor. Pump and motor coupling shall be T.B. Woods Sureflex elastomeric type.
- L. Stainless Steel Nameplate: Shall be attached to the pump giving the manufacturer's model and serial number, rated capacity, head, speed and all pertinent data.
- M. Pumps shall be mounted on a steel base plate with pump, coupling, coupling guard and motor.

## 2.4 MOTOR REQUIREMENTS

Drive motor shall be 25 HP, 1750 RPM, 460 volts, 3 phase, 60 hertz, 1.15 service factor, TEFC enclosure, C-face foot and flange mounted premium efficient motor. The motor should be sized for non-overloading conditions across the entire pump curve.

## **2.5 PREMIUM SURFACE PREPARATION**

Pump exterior shall be solvent washed, sandblasted, and coated with minimum 30 MDFT Themec Perma-Shield PL Series 431 epoxy. (Except motor)

JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference.
