Specifications for Wrecker Service

A contract for wrecker service for the East and West banks of Jefferson Parish for the Department of Fleet Management.

The wrecker service will be responsible for pulling drive shafts and axles when needed to prevent damage to other components of drive train system. The wrecker service must have wreckers capable of handling any vehicle or road equipment that is part of the Parish Fleet.

The Director of the Department of Fleet Management or his designees will determine wrecker to be used for each occurrence.

Quantities listed are for bidding purposes only. Actual usage may be more or less than quantities listed. The services listed are to be used to evaluate bid. Any exceptions should be entered on bid.

Wrecker service to be used by all Parish Departments, but approved only by Fleet Management.

Material Requirements:

All billing tickets must be forwarded to Fleet Management immediately at conclusion of haul. All billing tickets must be legible and clearly written. The following information must be posted on each ticket: Department, unit number, type of equipment, where tow commenced, where tow ended, amount, and total mileage towed. If it is necessary to have pickup ticket signed by department personnel other than Fleet Management Personnel, the ticket must be forwarded to Fleet Management and not given to any other department. Any tickets that are not handled as required, will not be considered for payment.

General Requirements:

Bidder shall possess a wrecker large enough to haul 100 foot ladder Fire Department trucks and Sewerage Vaccon trucks. Bidder shall have a large enough fleet of wreckers to accommodate the wrecker needs of Jefferson Parish without delays. Bidder subject to twenty-four(24) hour call, seven (7) days a week including holidays with a response time of one (1) hour or less (weather permitting). The bidder (contractor) may be required to clear streets, canals, neutral ground of vehicles during an emergency situation as directed by Jefferson Parish. The bidder (contractor) will be responsible for maintaining all insurance coverages as required by the laws of the State of Louisiana and Jefferson Parish requirements in reference to the operations of a vehicle wrecker/tow service. **The bidder (contractor) must submit all current insurance certificates with the bid submission.** Bidder (contractor) shall conform to the insurance requirements of LA R.S. 32:1717 governing wrecker/tow truck operations. **Bidder must also submit evidence of insurance coverage for "on-hook" coverage of not less than \$250,000.00**

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 

A contract for wrecker service for the East and West banks of Jefferson Parish for the Department of Fleet Management.

The wrecker service will be responsible for pulling drive shafts and axles when needed to prevent damage to other components of drive train system. The wrecker service must have wreckers capable of handling any vehicle or road equipment that is part of the Parish Fleet.

The Director of the Department of Fleet Management or his designees will determine wrecker to be used for each occurrence.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

☐ **WORKER'S COMPENSATION INSURANCE**

☒ **COMPREHENSIVE AUTOMOBILE LIABILITY**

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.
Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required unless otherwise specified in the bid. Such insurance is due upon contract execution.

1) **OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

2) **BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
