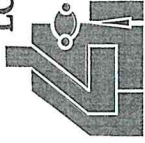

## **Section 2.0 – Scope:**

We extend this bid to cover all labor, materials, and necessary essentials to remove existing sod, sand grade ground level and install new sod at First Parish Court 924 David Drive Metairie, LA 70003.

## **Section 3.0 –License Requirements:**

The following Louisiana State licenses shall be required for this project:

- Contractor's License
- Specialty Landscaping, Grading and Beautification

## **Section 4.0 – Quantities/Inspection:**

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.



### **Section 5.0 – Bid Specifications:**

- Location of work area along West Metairie Drive and corner of David Drive to the driveway
- Remove existing sod with sod cutter
- Using sand, grade and level area using ditch witch
- Prepare area for sod installation
- Use 27 cubic yards of sand
- All work taken from 1/10' of final grades
- Install 10 pallets of St. Augustine sod
- Use sod roller to finish installation
- Clean and remove debris, blow area
- Water new sod thoroughly

### **Section 6.0 - Hours of Work:**

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (8:00am – 4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

### **Section 7.0 – Cleaning Area and Safety:**

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

### **Section 8.0 – Existing Structure**

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

**Section 9.0 – Warranty:**

All workmanship and material shall have a twelve (12) month warranty and shall supply the warranty in writing, from the company from the date of acceptance of the projects against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections, which may be required to make good all defects in materials and/or labor under its intended use, within the warranty period, at no cost to the owner.

**Section 10.0 – Pre-Construction Conference and Notice to Proceed:**

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.

## STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.
