6 INCH DeZURIK BUTTERFLY VALVE WITH ROTORK IQT3 ACTUATOR

ANSI/AWWA C504 Butterfly valves shall be model BAW as manufactured by DeZURIK or pre-approved equal.

Butterfly valves 6" DeZURIK butterfly valve or approved equal shall meet or exceed the latest revision of ANSI/AWWA Standard C504.

Valve bodies

Shall be of cast iron per ASTM A126 Class B or ductile iron ASTM A536 Grade 65-45-12. The disc is to have an offset design and provides an uninterrupted 360° sealing surface. The edge of the disc is to be made of solid 316 stainless steel. Disc-to-shaft pinning is to be provided by a stainless steel tapered pin (conforms to AWWA C504).

Valve shaft

Includes a shaft made of stainless to protect bearing and packing journal areas from corrosion. Upper and lower journal shaft bearings shall not need any lubrication. Shaft seals are to be self-compensating, V-type packing. Must have a minimum of four sealing rings. The seat shall be retained within a dovetail groove in the valve body and locked in place by an epoxy wedge. The seat is to also be adjustable and replaceable.

Coatings

Unless otherwise specified by customer, exterior and interior metallic surfaces of each valve shall be painted per the latest revision of ANSI/AWWA C504 or C516.

Actuators

Motor operator shall be Rotork IQT3 with 4-20 mA in/out position control mounted directly on top or approved equal. Motor power shall be 460V/3ph/60Hz and shall include a double O-ring sealed terminal compartment. Actuator shall be rated no less than IP68. Pushbuttons on the actuator are not allowed. Motor must have a built-in data logger, built in battery back-up, and come shipped with a hand held Bluetooth setting tool. Setting tool must be capable of downloading settings from actuator. Setting tool must allow for end user to make setting changes to the actuator without the removal of any covers. Price to include start-up by a certified Rotork representative. Complete assembly must be tested and shipped to the jobsite as a complete unit ready for installation.
