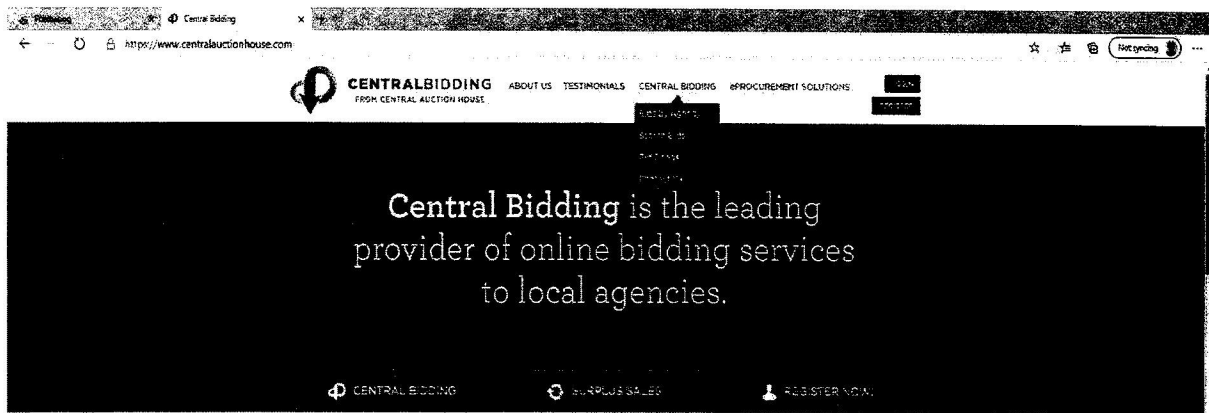

## **SECTION 7.0 - HOURS OF WORK:**

Work shall be performed during normal working hours. All work must be scheduled with owner representative 5 days in advance. The successful bidder shall work normal building working hours (7:00am – 4:00pm) to provide a safe work environment at no extra charge to Jefferson Parish.

## **SECTION 8.0 – CLEANING AREA AND SAFETY:**

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

### **SECTION 9.0 – WARRANTY:**

Material and labor shall be warranted for a period of one (1) year after completion.

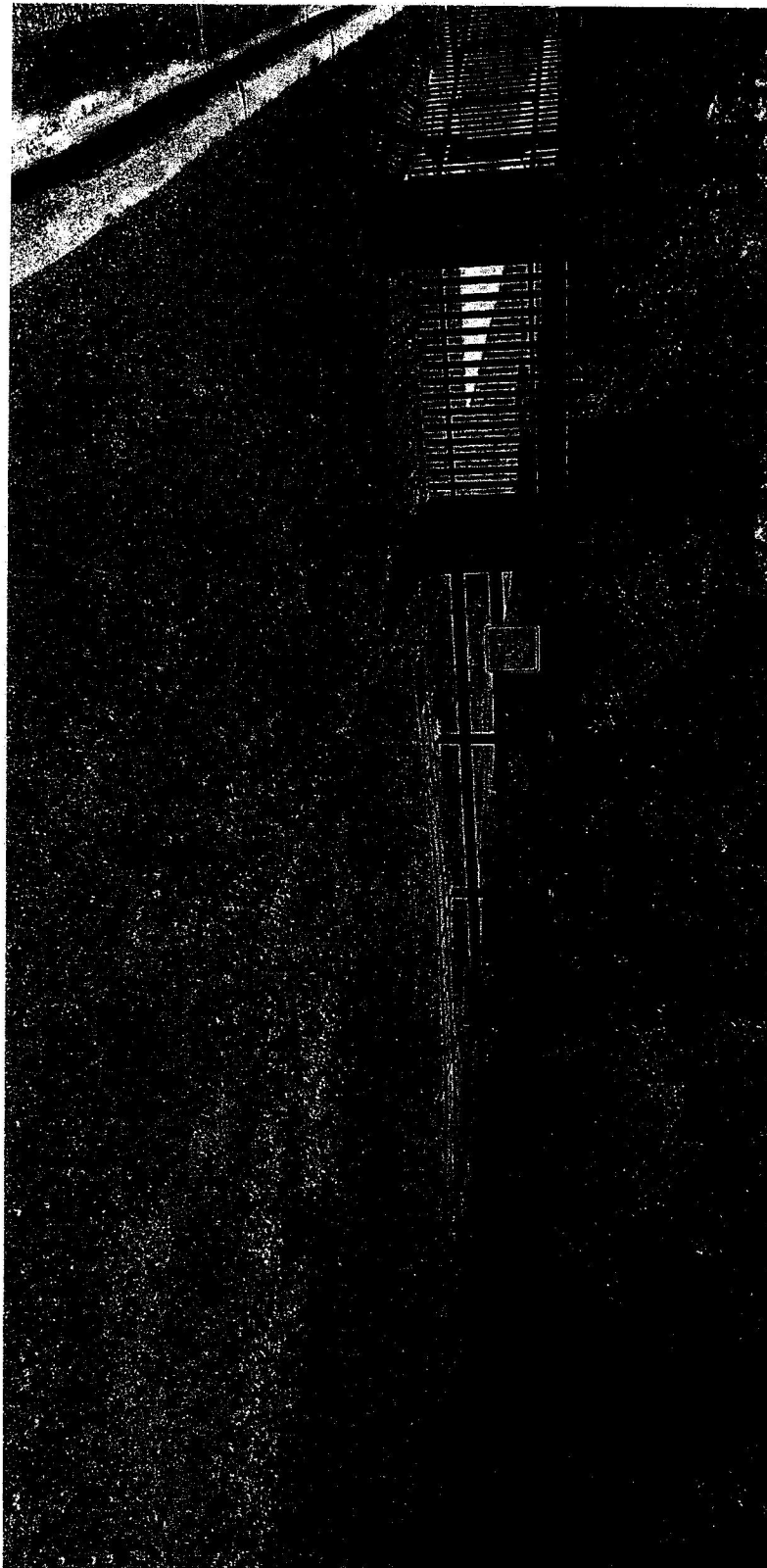
A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. A notice to proceed will be issued before any work commences.

### **SECTION 11.0– CONSTRUCTION/SCHEDULE TERM**

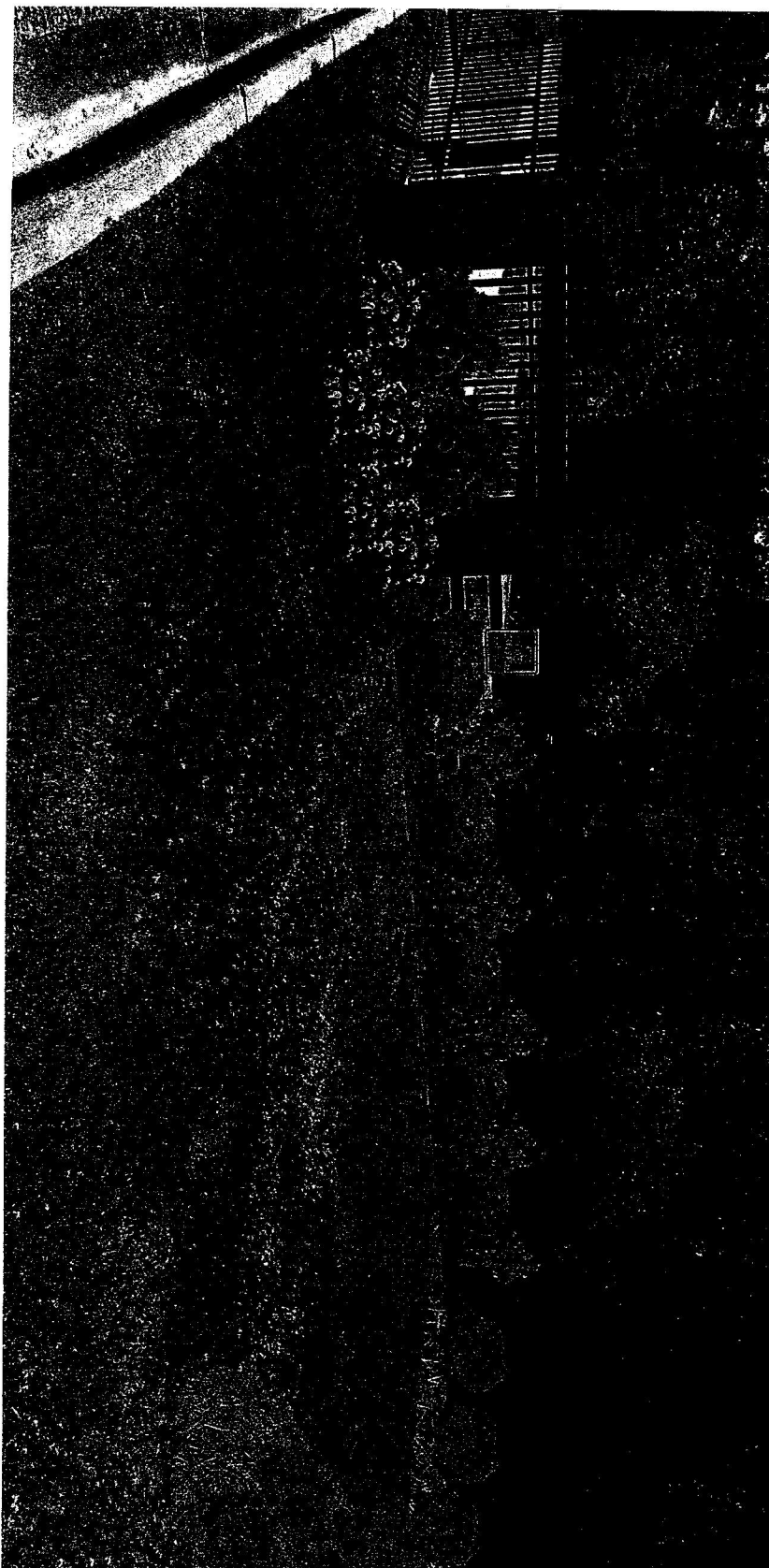

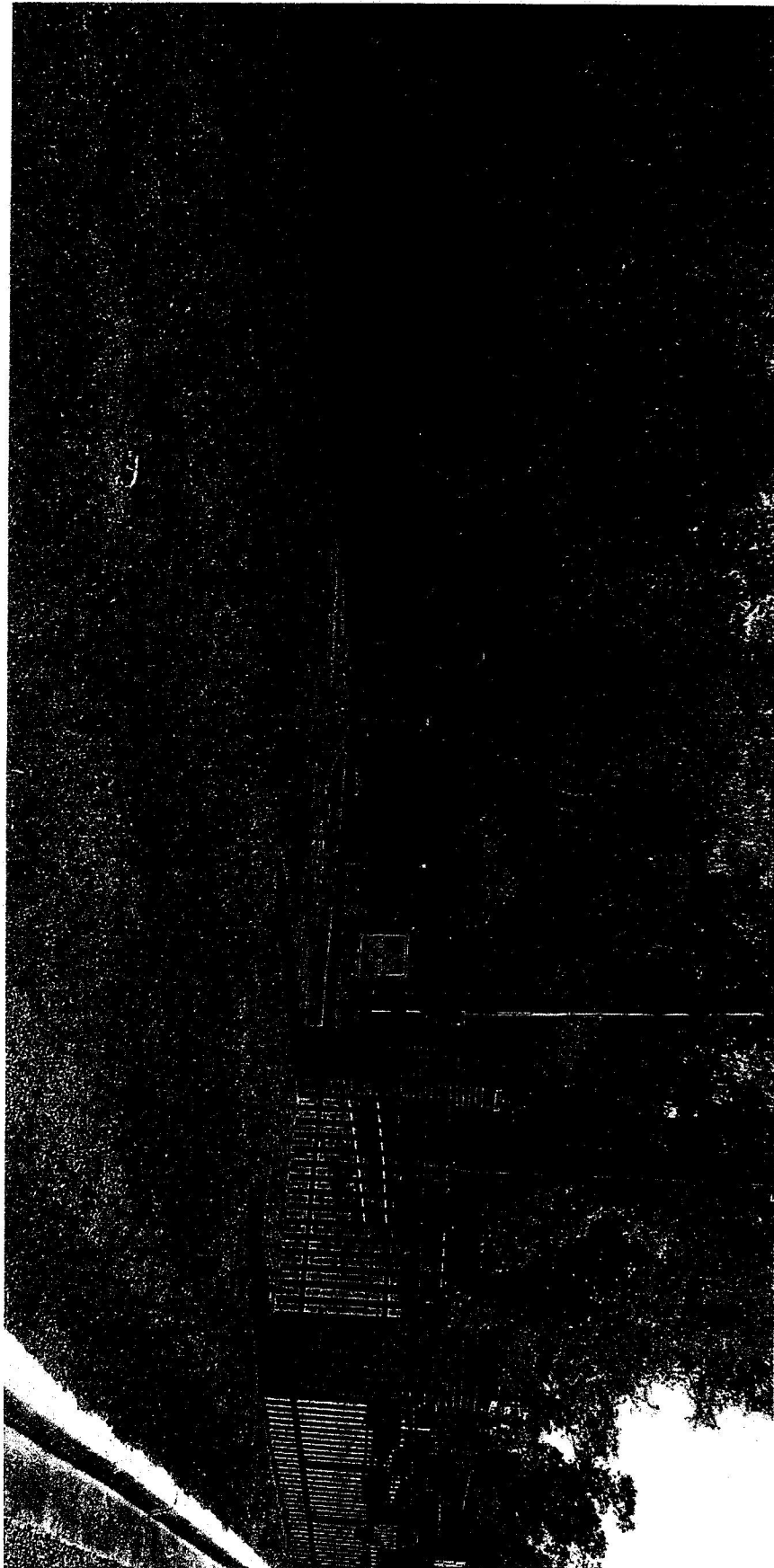
### **SECTION 12.0 – Liquidated Damages:**

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. 1. These materials have a one-year warranty with no maintenance for the contractor. It has been established that there is no irrigation at the site and material is only to be watered until project completion. Is it correct to assume that the warranty on the material does not include plants/sod that dies due to lack of water or lack of a pest control program? What are the standards to determine the cause of death/decay of the plants?
  - A) The standards will be considered at time of death, but it won't be because of lack of water. Documentation will be kept regarding Rainfall and times of watering by park staff, when there is a lack of rainfall. Graduate Horticulturist on staff, will determine cause of death. Usually, within the first month or so, if there is a problem with the plant or tree, it will show a sign of wilting, dropping leaves, etc.
2. Our grower asked if Sweet bay Magnolia could be substituted for Gum Tree Wild Fire.
  - A) Silver Maple was the substitute for the Sweet Gum Wildfire.
- 3 What color is requested for the 12 x 12 pavers? Are you wanting a cement or metal edging to hold the 300 sq ft of paver in place?
  - A) The color of the pavers will be red. We want plastic edging.
