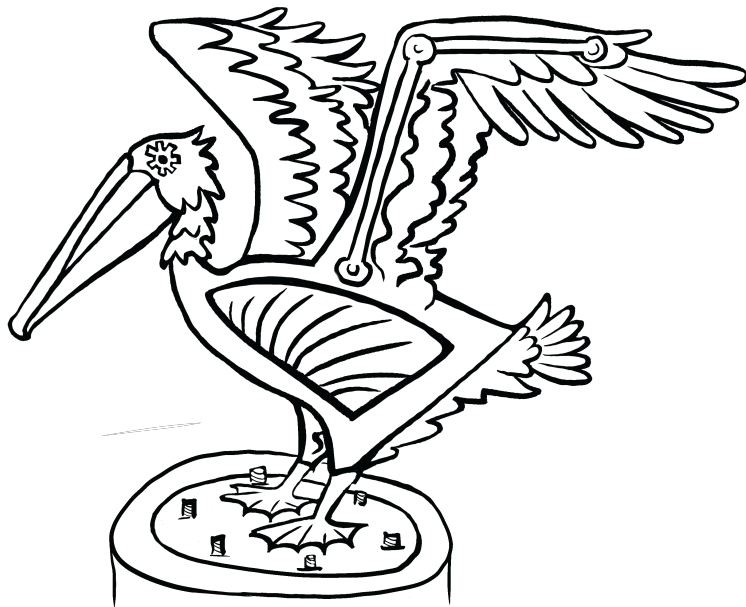
Mary Ann “Max” Bernardi is a multi-media artist living and working in the New Orleans regional area. Bernardi won the Jefferson Parish bid to paint the interior and exterior murals at Walkertown Bus Terminal in Marrero, LA, which was completed in 2021. When engaging in professional commissions, Bernardi is always willing to work with her clients, by creating sketches or samples, to develop a an artistic concept suited to their needs, and delivers work in a timely fashion with a polished final product.

The bid specifications call for a 100% steel sculpture with an ideal dimension of 10’T x 8-10’W, using a minimum of 50% recycled metal to create a unique, weathered look, with an emphasis on a cupped wing for the landing pelican. Within those perimeters, there are many approaches and materials that are possible. While I am presenting only 2D-concept sketches here, I acknowledge that it will be necessary to produce perhaps more than one miniature version of the sculpture concept before receiving approval to begin work.

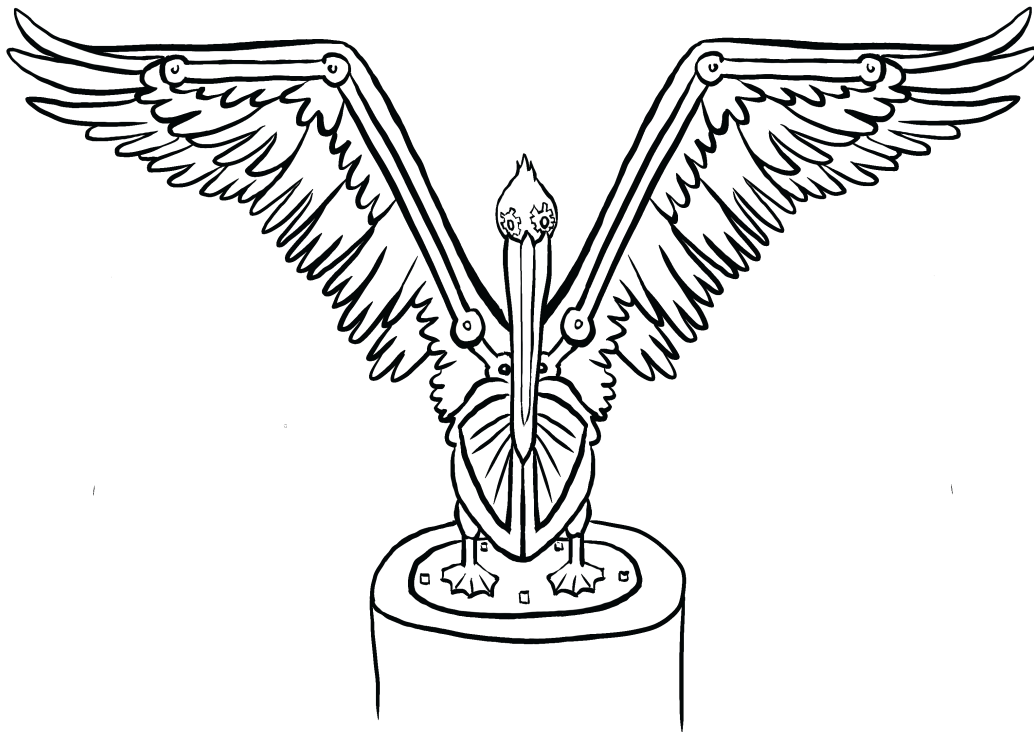
For this project, I propose to collaborate with the highly-experienced metal sculptor **Adam Farrington**. He is currently represented by Gryder Gallery, located at 615 Julia Street, and has a metal art fabrication studio on France St in New Orleans. He received his undergraduate degree in Fine Art from State University of New York at Purchase College, and has worked and resided in New Orleans since the mid-1990’s. He is known for his fantastical, often whimsical creatures, often a surreal combination that is part animal/part machine. He often uses recycled metals in his fabrication, and aside from welding equipment, he also has a bending brake and roller for manipulating metal. One of his ideas for this sculpture is to possibly use old white enameled bathtubs.

The base of the sculpture will be out of ½” thick steel plate cut to a 24”-36” round, which will be bolted down to the concrete pedestal, to be constructed at the site by Jefferson Parish. The armature will be a combination of 1” hollow square tubing for feet, body and the rising sections of the wings. The head, neck, and downward section of the wing, will be comprised of ½” round steel tubing, with a lattice of bent, then welded ½” round steel to create a rigid yet contoured form. The outer shell of the sculpture will be comprised of recycled steel, cut to resemble groups of feathers. The structure of the wing shapes, breast plate of the bird and eye may have sprockets or gears and resemble machine parts, if the maquette meets with the approval of the purchasing agent, Jefferson Parish.
