RESOLUTION NO. 132703

A resolution accepting the lowest responsible bid of Command Construction, LLC received on November 27, 2018 under Proposal No. 50-124635 in the amount of \$889,888.00 for Drainage Improvements on Paillet Ave., Estalote Ave., Esther St., and Brown Ave., Public Works Project No. 2018-004-DR (Council District No. 3).

WHEREAS, Jefferson Parish received bids on November 27, 2018 for the construction of Drainage Improvements on Paillet Ave., Estalote Ave., Esther St., and Brown Ave., Public Works Project No. 2018-004-DR; and

WHEREAS, Command Construction, LLC submitted the lowest responsible bid under Proposal No. 50-124635 in the amount of \$889,888.00; and

WHEREAS, the engineer, Kyle Associates, LLC, has reviewed the bids and has recommended that award of contract be made to Command Construction, LLC; and

WHEREAS, the project is being funded with a combination of CDBG and local funds and those funds are in place and are sufficient to construct the project.

NOW, THEREFORE, BE IT RESOLVED, by the Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

SECTION 1. That the lowest responsible bid received from Command Construction, LLC received on November 27, 2018 under Proposal No. 50-124635 in the amount of \$889,888.00 for Drainage Improvements on Paillet Ave., Estalote Ave., Esther St., and Brown Ave., Public Works Project No. 2018-004-DR, is hereby accepted.

SECTION 2. That the Chairperson of the Jefferson Parish Council, or in his or her absence the Vice-Chairperson, be and they are hereby authorized, empowered, and directed to sign and execute a contract with Command Construction, LLC, which contract shall include the bid proposal, plans and specifications for said project.

SECTION 3. That all work related to the construction of Drainage Improvements on Paillet Ave., Estalote Ave., Esther St., and Brown Ave., is to be charged to Account No. 45230-4039-7454(52356.082).

SECTION 4. That Community Development Block Grant funding for construction shall be provided from Account No. 21310-1195-139-7454 (13125.002).
