

On motion of **Mr. Conley**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

**RESOLUTION NO. 133659**

A resolution accepting the lowest responsible bid of **Fleming Construction Company, LLC** under Bid Proposal No. 50-00125075 for labor, material and equipment required for the Improvements to the David and York Lift Station (D6-9) for a base bid amount of \$783,392.00 and the cost of the contract not to exceed without an approved Change Order. (Council District 4)

**WHEREAS**, the Parish has engaged Aptim Environmental and Infrastructure, Inc. as part of the Sewerage Capital Improvement Program to prepare the plans and specifications for the Improvements to the David and York Lift Station (D6-9), SCIP Project No. C55101, hereinafter referred to as the Project; and

**WHEREAS**, Jefferson Parish has received bids on March 26, 2019, for labor, materials and equipment required for the project; and

**WHEREAS**, Fleming Construction Company, LLC submitted the lowest responsible bid under Proposal No. 50-00125075 at the total cost of \$783,392.00; and

**WHEREAS**, the bid of Fleming Construction Company, LLC is in order and within the available construction budget for the project; and

**WHEREAS**, Aptim Environmental and Infrastructure, Inc. has recommended that award of the contract be made to the lowest responsible bidder Fleming Construction Company, LLC.

**NOW, THEREFORE, BE IT RESOLVED**, by the Parish Council of Jefferson Parish, Louisiana acting as governing authority of said Parish:

**SECTION 1.** That the lowest responsible bid of Fleming Construction Company, LLC received March 26, 2019, under Proposal No. 50-00125075 in the amount of \$783,392.00 for labor, material and equipment required for the Improvements to the David and York Lift Station (D6-9), SCIP Project No. C55101 be and is hereby accepted.

**SECTION 2.** That the cost for this construction is to be funded from Account No. 44940-4023-7454(49412.019) of the Department of Sewerage.

**SECTION 3.** That maximum expenditures shall not exceed \$783,392.00 without an approved change order.

**SECTION 4.** That the term of this contract shall commence from the date indicated on the Notice to Proceed.

**SECTION 5.** That the Council Chairperson or in his or her absence, the Vice-Chairperson be and is hereby authorized to execute any and all documents necessary to give full force and effect to this resolution.
