The order must not be filled at a higher price than quoted. Section 1.0 - Pre-Bid Conference:

All prospective bidders are invited to attend this non-mandatory pre-bid conference which will be held at date and location above. However, failure to attend the non-mandatory pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the non-mandatory pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner. This conference is held to allow questions to be answered and to inspect the site with the owner's representative.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, and necessary essentials to remove one (1) existing grease trap interceptor system and supply and install one (1) new Great Basin GB-250 or owner reviewed and approved equal grease trap interceptor system at the Jefferson Parish Emergency Operation and Communication Center located at 910 3rd Street, Gretna, LA 70053.

Section 3.0 –License Requirements:

The following Louisiana State licenses shall be required for this project:

- Mechanical Work and
- Plumbing

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section: 5.0 – Standards:

All work shall meet or exceed the following industry standards:

- National Fire Protection Agency (NFPA)
- National Electrical Code (NEC)
- National Standard Plumbing Code (NSPC)

Section 6.0 Specifications:

The successful bidder shall supply all labor, materials, delivery, and necessary essentials to perform the following:

- Remove and properly dispose of one (1) existing grease trap interceptor system and all associated materials
- Supply and install one (1) new Great Basin GB-250 or owner reviewed and approved equal grease trap interceptor system.
- Supply and install all new piping, fittings, supports, etc.
- All new piping, supports, fittings, etc. shall match existing materials
- All equipment shall be installed as per all local, state, federal codes.
- All equipment shall be bidder supplied new.
- Start up and check the Grease Trap for proper operation and leaks.

Section 7.0 - Hours of Work:

The work that is to be performed shall be scheduled during normal working hours 8:00 a.m. – 4:00 p.m. Monday thru Friday. All work shall be scheduled seventy two (72) hours in advance. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish. The successful bidder shall coordinate all shutdowns or disruptions of essential services of the existing facilities with the owner.

Section 8.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

There must be a fire watch present when any cutting, burning, or welding is taking place; and 2 hours thereafter. The fire watch and his equipment will be the sole responsibility of the successful bidder.

Section 9.0 – Warranty:

All workmanship and materials shall have a minimum of one (1) year parts and labor warranty in writing, from the manufacturer and the basin shall have a lifetime corrosion warranty from the manufacturer starting from the date of acceptance of the project against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

Section 10.0 – SDS:

The bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances that will be brought to and/or used at the workplace. The bidder shall provide SDS as per this requirement to the Director of the Jefferson Parish Department of General Services.

Section 11.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Certificate of Final Inspection must be submitted to the Department of General Services before final payment is rendered.

Section 12.0 – Existing Structure:

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the contractor shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 13.0 – Hot Work Permit:

The successful bidder shall obtain a burn permit form from the Department of General Services before any cutting, soldering or welding is performed.

At no additional cost to owner the successful bidder shall provide a fire watch when any cutting, burning, or welding is taking place; and 2 hours thereafter. The fire watch and their equipment will be the sole responsibility of the successful bidder.

Section 14.0 – Liquidated Damages:

Commencing on the eleventh day following the notice to proceed until work is substantially complete, liquidated damages will be assessed in the amount of \$100 dollars per day.

Section 15.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences.

No materials shall be ordered until the successful bidder receives a written “Notice to Order Materials” from the Department of General Services or Emergency Management.

No work shall be performed until the successful bidder receives a written “Notice to Proceed” to begin work, from the Department of General Services or Emergency Management.

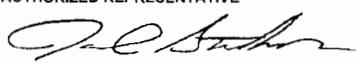
