

On motion of **Mr. Roberts**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

RESOLUTION NO. 132170

A resolution accepting the lowest responsible bid of **Boland Marine & Industrial, LLC**, under Bid Proposal No. 50-00123661, for a two year contract to be provided on an as-needed basis for Machine Shop Services for the repair of components related to pumping machinery for the Drainage, Water and Sewerage Departments at the bid tabulation price of \$90,000.00. Maximum expenditures for this contract shall not exceed \$850,000.00 for the two years, by a factor of not more than 10% without amendment to the contract authorized by resolution of the Council. (Parishwide)

WHEREAS, there was one (1) bid received for Bid Proposal No. 50-00123661; and,

WHEREAS, Boland Marine & Industrial, LLC submitted the lowest responsible bid of ninety thousand dollars \$90,000.00 on all individual bid items and is the only responsible bid overall; and,

WHEREAS, expenditures to date have totaled \$630,413.00 for the current contract with Boland Marine & Industrial, LLC, for the period from August 24, 2016 to August 23, 2018; and,

WHEREAS, the current contract expired on August 23, 2018; and,

WHEREAS, maximum expenditures shall not exceed \$850,000.00 for the two (2) years, for a two year contract to be provided on an as-needed basis for Machine Shop Services for the repair of components related to pumping machinery for the Drainage, Water and Sewerage Departments at the bid tabulation price of \$90,000.00.

NOW, THEREFORE, BE IT RESOLVED, by the Jefferson Parish Council, the governing authority of said Parish:

SECTION 1: That the lowest responsible bid under Bid Proposal No. 50-00123661 from Boland Marine & Industrial, LLC for a one (2) year contract Machine Shop Services for the repair of components related to pumping machinery for the Drainage, Water and Sewerage Departments, be and is hereby accepted.

SECTION 2: That the Purchasing Department be and is hereby authorized to issue a Purchase Order and/or contract as made necessary by this award.

SECTION 3: That expenditures are to be charged to Account Number 45120-4037-7454(52110.001).

SECTION 4: That the cumulative total expenditures under Bid Proposal No. 50-00123661 shall be limited to \$850,000.00. Compensation shall not exceed this amount by a factor of more than ten percent (10%) without amendment to the contract authorized by resolution of the Council.

SECTION 5: That the Chairwoman of the Jefferson Parish Council, or in her absence the Vice-Chairperson, be and is hereby authorized to sign and approve any and all documents necessary to implement this resolution.
