SPECIFICATIONS FOR BID

ONE TIME PURCHASE OF CATENARY RAKE CHAIN

The intent of this specification is to define the minimum requirements of the Parish of Jefferson for the purchase 1,000 links of catenary rake chain.

Submittals:

The following is required with the bid submittal:

- A complete specification and submittal of all components of the chain

The following will be required upon request from the Drainage Department after the bid opening but prior to bid award.

- One copy of all link "Bill of Materials" of the unit's construction, cutaway drawings, and dimensions as offered to confirm compliance with the current chains.

Mere attachment of brochures covering standard manufactured equipment shall not be adequate.

Qualifications:

Steel must be American made.

Factory Assembly and Delivery:

Links shall come assembled in sections of 20 links each for shipping. Freight shall be included in base bid. The chains shall be delivered to the Ames pump station warehouse located at 5100 Rochester Drive, Marrero, LA 70072. All deliveries shall be made during normal operating hours between 7:00 AM and 3:00 PM Monday through Friday. Deliveries will not be accepted during Jefferson parish holidays.

Steel Certificate of origin is required with delivery of chains

Specifications:

The rake chains shall be matched strands of steel thimble roller chain having identical pitch and carbon steel straight side bars, and an ultimate strength of 40,000 pounds. The chains shall also have case-hardened steel thimbles, heat treated steel pins, and straight faced, hardened steel rollers with stainless steel cotter pins. Bushing, roller, and pin shall be CHT heat treated. No grease or oil, just plain links.

Basis of Design: Tsubaki D-963-R plain chain with SS t-head cotter pins.




Figure 1: Chain Dimensions




Figure 2: Picture of Chain application

Dimensions of chain shall match the following Figure 1 below and a picture of application is shown in Figure 2:
