**Section 2.0 - Scope:**

We extend this bid to cover all labor, materials, delivery, equipment and all other incidentals necessary to remove existing floor covering and cove base and install new bidder supplied floor covering and cove base in suite 402 of the Joseph S. Yenni Building located at 1221 Elmwood Park Boulevard, Jefferson, LA, 70123.

**Section 3.0 -License Requirements:**

The following Louisiana State license shall be required for this project:

- Commercial License

And a

- Louisiana State Specialty License in Stone, Granite, Slate, Resilient Floor Installations, Carpeting

And/or a

- Louisiana State specialty license in flooring and decking

**Section 4.0 - Quantities/Inspection:**

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of labor and materials required to complete this project.



**Section 5.0 - Bid Specifications:**

- All materials shall be bidder supplied new
- All materials shall be as specified or owner reviewed and approved equal
- All materials shall be installed as per manufacturer recommendations and guidelines
- Flooring and cove base shall fit neatly against vertical surfaces, into breaks and recesses, against bases, and penetrations, and thresholds, against door frames.
- Materials shall match existing floor covering, cove base, and threshold transitional strips.
- Transition strips shall meet or exceed ADA guidelines and standards.

**Removal of Floor Covering, Cove Base, and furnishings:**

- Remove and properly dispose of existing floor covering and cove base.
- Remove and re-install all furnishings in the space where work is to be performed
- Owner will remove and reinstall all electronic equipment
- Location of carpet that is to be removed and re-installed shall be field verified with a Jefferson Parish representative prior to the start of the project.

**Floor Preparation:**

- Prepare existing subflooring as per new flooring manufacturer guidelines.
- ARDEX Featheredge floor leveler shall be used to level floor surface, provide and install five (5) ten pound bags total. All remaining bags shall be turned over to owner at completion of project.

**Installation of carpet tile and cove base:**

- Carpet tiles and cove base shall be installed in all locations where carpet tiles and cove base are installed now.
- Supply and install Interface Satori style 5143 Meditate carpet tiles.
- Carpet tiles shall be installed using the Ashlar Method of Installation.
- Carpet tiles shall be applied to the surface using Tac Tile Adhesive Strips.
- The use of adhesives will not be allowed to install carpet tiles.
- Supply and install Reppe 1/8" thick, 4" wide Type TS RP100 1/8" vulcanized SBR rubber black cove base with toe
- Adhesive for cove base shall be applied in accordance with all manufacturer recommendations and guidelines.
- Install new black low profile rubber transitional strips in all door thresholds and any other area required to complete this project.
- Use the Ashlar method of installation using TAC Tiles for this project.

**Cleaning:**

- Upon completion of the installation, remove all waste materials, tools and equipment.
- Prior to final acceptance, thoroughly vacuum the entire floor surface using commercial vacuums.
- Remove all spots/smears or replace carpet where spots/smears cannot be removed.

**Section 6.0 - Hours of Work:**

The work that is to be performed shall be scheduled during normal working hours 7:30 a.m. - 4:30 p.m. Monday thru Friday. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

**Section 7.0- Existing Structure:**

Should any modifications to the facility be required during this project, the successful bidder shall restore the facility to its original condition, with the same type materials, finish, and workmanship.

**Section 8.0- Cleaning Area and Safety:**

Job site must be clean and free of all litter and debris caused by this work daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Storage of flammable materials will not be permitted on the premises. All flammable materials must be removed from the job site daily. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

**Section 9.0 - Warranty:**

- All workmanship shall have a minimum of one (1) year all parts and labor warranty.
- Materials warranty: Carpet shall have a 15 year warranty and cove base shall have a warranty for two (2) years, year 1: 100% material costs, 100% labor costs, year 2: 100% material cost, 50% labor cost.

Both warranties will commence on the date of acceptance of the project.

**Section 10.0 - Liquidated Damages:**

Commencing on the fifteenth day following the notice to proceed until work is complete, liquidated damages will be assessed in the amount of \$300 dollars per day.

**Section 11.0 - Pre-Construction Conference and Notice to Proceed:**

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No materials shall be ordered until the successful bidder receives a written Notice to Order Materials and no work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.

determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

- (1) The work to be performed by the classification requested is not performed by a classification in the wage determination; and
- (2) The classification is utilized in the area by the construction industry; and
- (3) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.
