The successful bidder shall have the doors individually engineered to fit the existing enclosure.

The lock system will be key/thumb turn hook-bolt. All keys will be given to owner.

The door and components shall be clear anodized aluminum.

The door shall comply with all A.D.A., ANSI A156.10, N.F.P.A., UL, regulations and local building codes.

The successful bidder shall supply all signage, such as (caution automatic door), (In Emergency push to open), etc.

The old doors shall be removed by the successful bidder.

The owner shall supply 110 volts at the door location.

The locking device shall be the pin lock type. When the door is in the unlocked mode, it shall open and close automatically by way of motion sensor.

The door must have panic hardware to break away in case of emergency.

Section 4.1 Hours of Work:
