Price Includes:

- Two (2) Fire Alarm Inspection per building listed below. Once per year as required according to State and NFPA guidelines.
- One (1) Sensitivity test per building listed below as required according to State and NFPA guidelines.
- Testing of all manual stations, system detectors, duct detectors, elevator recall and audio-visual devices.
- Owner to supply access to all guest rooms and restricted areas, if required.
- Inspection to be performed during normal business hours, 8:00 am to 5:00 pm Monday thru Friday.
- Written documentation of testing per NFPA 72 will be included.
- **Please note all Exclusions and Terms and Conditions below.**

Exclusions:

- Repairs due to vandalism, neglect or acts of God.
- Repairs of pre-existing conditions.
- Repairs of faulty wiring.
- Repairs of tamper/flow switches.
- Customer to provide access to hard to reach areas.
- Panel parts replacement excluded.
- Peripheral replacement excluded (I.E. System Smoke Detectors, Heat Detectors, Pull Stations, Audible/Visual Devices, Emergency Pull Cords, ETC.)
- Price does not include sensitivity testing unless explicitly stated in the "Price Includes" section of this document.
- Price does not include testing of 120v smoke detectors that are not connected to the fire alarm panel. The customer is responsible to test these devices themselves annually.
- **Price does not include cost of lift, if required.**

6. There will be a rescheduling fee of no more than 10% of the inspection cost in the event a scheduled inspection is cancelled by the customer within 48 hours of said inspection.
7. **Overtime or any return visit required due to schedule revisions, job acceleration, delay caused by others or circumstances beyond ADS Systems control are not included and will be an additional cost to the customer.**
