SECTION 72. Section 31-7-15, Mississippi Code of 1972, is amended as follows:

Whenever two (2) or more competitive bids are received, one or more of which relates to
commodities grown, processed, or manufactured within this State, and whenever all things stated
in such received bids are equal with respect to price, quality, and service, the commodities grown,
processed, or manufactured within this State shall be given preference. A similar preference shall
be given to commodities grown, processed, or manufactured within this State whenever purchases
are made without competitive bids, and when practical the Office of General Services may by
regulation establish reasonable preferential policies for other commodities, giving preference to
resident suppliers of this State.

Any foreign manufacturing company with a factory in the State and with over fifty (50) employees
working in the State shall have preference over any other foreign company where both price and
quality are the same, regardless of where the product is manufactured.

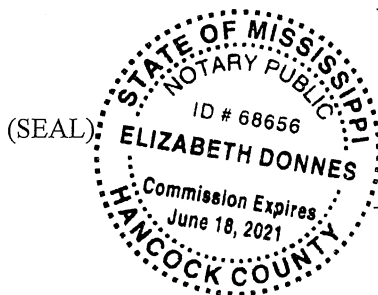

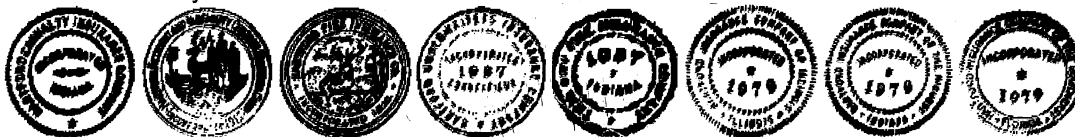
