In compliance with your Notice to Bidders, BIDDER hereby proposes to perform all WORK for the construction of Project No. TENNIS COMPLEX Grading, Drainage & Erosion Control, In strict accordance with the CONTRACT DOCUMENTS, within the time set forth therein, and at the prices stated below.

By submission of this BID, each BIDDER certifies, and in the case of a joint BID each party thereto certifies as to its own organization, that this BID has been arrived at independently, without consultation, communication, or agreement as to any matter relating to this BID with any other BIDDER or with any competitor.

BIDDER hereby agrees to commence WORK under this contract on or before a date to be specified in the NOTICE TO PROCEED and begin work clearing the project site, removing trees, installing silt fence, and striping/stockpiling topsoil. Excavation of the new band field area will be completed next. Final grading, topsoil placement, seeding and mulching of the new band field area will then be completed prior to any other work. Cut excavation from the new band field area will be placed on the proposed band storage building pad. Upon completion of the new band field area, work will continue on the remaining excavation until all final site grading is achieved, drainage pipe are installed, and seeding and mulching is completed. Once substantial grass growth is achieved, silt fence will be removed. The contractor will fully complete the PROJECT within sixty (60) working days therewith.

BIDDER further agrees to pay as liquidated damages, the sum of \$200.00 for each working day thereafter as provided in the General Conditions. Rain Days, as determined by the **OWNER**, will be added to the contract completion date.
