MOBILE SECURITY CAMERA LEASE **FOR THE JEFFERSON PARISH** **DEPARTMENT OF PUBLIC WORKS-PARKWAYS DEPARTMENT**

SCOPE OF WORK

The Jefferson Parish Department of Public Works – Parkways Department (Parkways) is soliciting qualified Contractors for a six (6) month long turnkey lease of a mobile security camera (trailer) system.

BID BOND

A bid bond in the amount of 5% of the total bid price is due with the bid submission.

PRE-BID CONFERENCE

There will be no pre-bid conference for this bid. All questions related to this bid must be submitted to the Jefferson Parish Purchasing Department.

INITIAL INSTALLATION SITE

The mobile camera system shall be initially installed by the Contractor in the vicinity of the intersection of Live Oak Boulevard and Willswood Lane in Westwego, Louisiana.

The Contractor shall provide unit pricing for mobilization and demobilization of the camera system. At the discretion of Jefferson Parish, the camera system shall be relocated by the Contractor no more than one time per two months for the life of the contract. For the six-month contract, Jefferson Parish may request that the camera system be relocated up to two times after the initial installation. The Contractor provided unit pricing for mobilization and demobilization shall be the basis of payment for each requested relocation.

If Jefferson Parish requests that the camera system be relocated during the contract period, relocation would occur within unincorporated Jefferson Parish with a maximum travel distance of 20 miles.

The contract shall have a minimum of one (1) mobilization and one (1) demobilization.

PERIOD OF AGREEMENT

The term of the contract shall be for six (6) months.

INVOICING

Invoicing shall occur on a monthly basis and shall only include work and/or the lease occurring during the month being invoiced. The first and last months' invoices may be prorated based on the start/end date of the contract.

MINIMUM EQUIPMENT REQUIREMENTS

The Contractor shall supply and install a mobile (trailer) camera system meeting the below minimum requirements:

- Trailer must have 24/7 solar charge autonomy – no power source will be provided by Jefferson Parish;
- Trailer must have a minimum 20' height camera tower;
- Trailer must include a minimum of one (1) IR (infrared) PTZ (pan, tilt, zoom) camera for monitoring;
- Camera must be a minimum 3 MP (mega pixels) camera with a minimum 36x zoom and a minimum 1080p HD (high definition) video;
- PTZ camera shall have auto-tracking motion capabilities;
- Trailer must have GPS location and geo-fencing capabilities;
- Trailer must include available audio interaction;
- Recorded camera footage must be remote accessible at any time by Jefferson Parish;

- Trailer and camera system shall have remote diagnostics for manufacturer monitoring, adjustment or repair.


LIQUIDATED DAMAGES

Once installation is complete (initial or subsequent locations), the mobile camera system must be able to continuously capture video surveillance for the life of the contract. Any lapses in video footage due to improperly working equipment may be subject to liquidated damages of \$25 per hour of missing video footage.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

☒ **WORKER'S COMPENSATION INSURANCE**

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

Note: If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being

rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

☒ **COMMERCIAL GENERAL LIABILITY**

Shall provide limits not less than the following: \$1,000,000.00 Combined Single Limit per Occurrence for bodily injury and property damage.

☒ **COMPREHENSIVE AUTOMOBILE LIABILITY**

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.
Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required if selected below. Such insurance is due upon contract execution.

☐ **OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

☐ **BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
