By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.

Specifications for Ammonium Hydroxide Solution

- A. The 29.4% ammonium hydroxide solution must be certified for use in drinking water under National Sanitation Foundation Standard 60.
- B. The bid price of the ammonium hydroxide shall include any and all fees associated with drum return, such as an environmental or cleaning fee.
- C. Shippers must provide necessary properly sized equipment to quickly unload their product at the delivery site.
- D. Ammonium Hydroxide Solution must be packaged in 55-gallon drums delivered freight prepaid in 12 drum shipments to 171 Birch Lane, Grand Isle, LA 70358 and 509 Highway 1, Grand Isle, LA 70358. Deliveries must be made as required and within 7 calendar days after the order is placed.
- E. Total quantity for the 2-year contract is 144 drums.
