SECTION 1.0 – SITE VISITS:

There will be no pre-bid conference for this bid. All prospective bidders are encouraged to visit the site prior to submitting a bid. Please Contact Bryan Parks @ 504-349-5800

SECTION 2.0 – SCOPE:

We extend this bid to cover all labor, equipment, materials, freight and necessary essentials to trim and remove vegetative debris from the western side of the Weyerauch Canal to the existing roadway in Gretna, Louisiana. The limits of work shall consist of the western canal right-of-way near the intersection of Commerce Street extending to Lapalco Boulevard.

SECTION 3.0 –LICENSE REQUIREMENTS:

The following Louisiana State license shall be required for this project:

- Sub-Category: Landscape, Grading and Beautification

These licenses are required to be valid through the contract term.

SECTION 4.0 – EXISTING SITE:

The work area consists of the western right-of-way of the Weyrauch Canal from the Commerce Street intersection to Lapalco Boulevard. The area is comprised of an existing bamboo and oak tree screen that provides a visual buffer of the drainage canal from the residences along the west side of the roadway. The Contractor shall take care as to not damage any of the existing site features including, but not limited to, the roadway, utilities and vegetation.

SECTION 5.0 – BID SPECIFICATIONS:

- The Contractor shall be responsible for selectively clearing a minimum of 5' from the edge of the roadway towards the drainage canal. No removal is required beyond 5' from the edge of the roadway.
- In an effort to maintaining screening of the adjacent canal, no complete clearing of existing vegetation shall occur.
- Clearing shall include the removal of dead and/or declining bamboo canes, green debris, litter and undesirable vegetation such as vines, weeds and invasive species.
- In addition, the Contractor shall remove any bamboo canes overhanging the roadway and/or the 5' minimum clear zone from the edge of the roadway. When removing bamboo canes, the Contractor shall make an effort to cut the canes back from the ground. It shall not be acceptable to simply trim the portion of the cane overhanging the clear zone.
- No trees shall be removed as part of this contract.
- No oak trees shall be damaged or removed during this project.
- Spraying of herbicide shall not be allowed.
- It will not be acceptable for the Contractor to allow any vegetation or debris to enter the drainage canal.
- It shall not be acceptable for the Contractor to push any vegetation or debris into the existing bamboo screening. All unwanted vegetation shall be removed from the site.
- The Contractor shall determine the type, size and quantity of equipment for this project.
- All removed vegetation, green debris and litter shall be removed from the site and properly disposed of by the Contractor. The use of containers and/or chippers is recommended for disposal. The Contractor shall coordinate container delivery and removal, as needed, so that no containers are blocking the roadway without the Contractor present at the site. At least one lane of traffic shall be passable at all times.
- The Contractor shall determine his schedule to complete the work. However, once the Notice to Proceed is issued, the Contractor shall have up to fourteen (14) calendar days to complete the project (weather dependent).

SECTION 6.0 - HOURS OF WORK:

Work shall be performed during non-holiday weekdays between the hours of 8:00 am and 4:00 pm. The Contractor shall provide the Jefferson Parish Parkways Department with a minimum twenty-four (24) notice prior to the start of work. Once the Contractor's work is complete, the Contractor shall contact the Jefferson Parish Parkways Department to schedule a final inspection of the work.

SECTION 7.0 – CLEANING AREA AND SAFETY:

The job site must be clean and free of all litter and debris daily and upon completion of the contract. The Contractor shall install safety fencing around any areas of his work that may present a danger to the general public when he is not on site working. Equipment and material storage shall not be permitted on site. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

As-needed traffic control shall be the responsibility of the Contractor. When blocking a lane of traffic, the Contractor shall be required to properly cone and flag the work area to notify pedestrians and motorists of his operations. The Contractor shall only be allowed to block traffic within the vicinity of his operations. The Contractor shall not block any lanes of traffic when he is not on-site and working.

SECTION 8.0 – PRE-CONSTRUCTION CONFERENCE AND NOTICE TO PROCEED:

A Pre-Construction Conference will not be necessary for this project. However, a Jefferson Parish Parkways Department employee will be available to meet the Contractor at the site to answer any questions. No work shall be performed until the successful bidder receives a written "Notice to Proceed" or "Purchase Order" from the Jefferson Parish.


