Section 1.0 – Pre-Bid Conference:

All bidders are required to attend the **Mandatory** Pre-Bid Conference and sign-in as a record of attendance. Failure to attend this conference shall preclude vendors from submitting a bid. Late bidders will not be allowed to sign-in as the pre-bid meeting is mandatory.

Section 2.0 – Scope:

We extend this bid to cover the following work:

- Remove four (4) existing roof-top air conditioning-heater package units
- Provide and install four (4) new roof-top air conditioning-heater package units
- Provide necessary roof work to accommodate new roof-top air conditioning-heater package units.

Section 3.0 – License Requirements:

A Louisiana State license in the following category(s) shall be required for this project:

- Louisiana State Mechanical Contractor's License will be required for all HVAC/mechanical work.

Section 7.0 – Bid Specifications:

The following work shall be performed:

- Remove existing HVAC units, install new bidder supplied HVAC units and provide necessary roof work to accommodate new HVAC units.
- All materials for this project shall be new.
- Bidder shall indicate on the bid form the make and model of the proposed unit(s), if other than owner specified. If make and model is not noted, then the successful bidder must provide the brand and model numbers stated within our specifications.
- Bidder shall include specifications on the proposed unit(s) with the bid package if other than owner specified. Failure to provide this information will result in bid rejection.
- Install four (4) new bidder supplied rooftop units in removed unit's locations.
- Design, supply and install new 24 gauge sheet metal ductwork to connect new units to existing ductwork.
- Design and engineer new metal deck to accommodate new bidder supplied units.
- All Ductwork is to be internally insulated.
- Design/engineer, supply, and install new sheet metal canvas connectors for supply and return ductwork on all units.
- Supply and install four (4) new Square D 100 amp 3 phase NEMA 3 fused disconnect box with manufacturer approved new fuses to fit owner supplied unit.
- Supply new fuses for each disconnect as per manufacturer guidelines.
- Fused disconnect shall be mounted to new roof top unit. All hardware shall be stainless steel.
- All mounting hardware shall be stainless steel.
- All electrical equipment shall be weather tight and UL approved.
- Supply and install new conduit and copper wire from new pitch pockets to fuse disconnect box mounted on all roof top units.

Section 7.3 – Roof Work:

- Install four (4) new bidder provided and engineered roof curbs.
- Install new metal deck to accommodate the four (4) new bidder supplied HVAC units.
- All roof work shall be performed by a Louisiana State licensed roofing company.
- Properly secure roof curb flanges to roof deck.
- All units shall be properly secured to roof to prevent movement during high winds.
- Properly flash the roof supports to each unit.
- All flashing shall be new 316 stainless steel.
- All hardware shall be stainless steel.
- Roofing contractor shall match existing roofing material.
- Supply and install new 6" x 6" 316 stainless steel pitch pocket for electrical feed as needed. See "PITCH POCKET DETAIL" attachment "B".
- Supply all materials needed to protect interior of building and roof during this project.
- All Roof work must have a (1) year guarantee on all materials and labor

Section 8.0 – Commissioning:

Commissioning shall be performed by a factory trained representative of the installed HVAC equipment. All commissioning shall be performed with an owner's representative present.

Section 9.0 – Hours of Work:

The work that is to be performed shall be scheduled during normal working hours 7:00 a.m. – 5:00 p.m. Monday thru Friday. All work shall be scheduled seventy two (72) hours in advance. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

Section 10.0 – Existing Structure:

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the contractor shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 11.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

There must be a fire watch present when any cutting, burning, or welding is taking place; and 2 hours thereafter. The fire watch and his equipment will be the sole responsibility of the successful bidder.

Section 12.0 – Warranty:

All workmanship and materials shall have a minimum of five (5) years parts and labor warranty in writing, from the manufacturer starting from the date of acceptance of the project against defects. The bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacements, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period, at no cost to the owner.

The successful bidder will also guaranty that he will hold the Parish of Jefferson harmless from any damage arising from faulty workmanship or materials performed and/or installed within the duration of the warranty.

Section 13.0 – Safety Data Sheet (SDS):

The successful bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances that will be brought to and/or used at the workplace. The successful bidder shall provide SDS as per this requirement to the Director of the Jefferson Parish Department of General Services.

Section 14.0 – Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement. The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project.

Certificate of Final Inspection must be submitted to the Department of General Services before final payment is rendered.

Section 15.0 – Hot Work Permit:

The successful bidder shall obtain a burn permit form from the Department of General Services before any cutting, soldering or welding is performed.

At no additional cost to owner the successful bidder shall provide a fire watch when any cutting, burning, or welding is taking place; and 2 hours thereafter. The fire watch and his equipment will be the sole responsibility of the successful bidder.

Section 16.0 – Liquidated Damages:

Liquidated Damages in the amount of \$500.00 per day will be assessed for each day that expires ten (10) days from the date of the "Notice to Proceed" until work is substantially completed.

Section 17.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference shall be held between the successful bidder and the owner before any work commences. No materials shall be ordered until the successful bidder receives a written Notice to Order Materials and no work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work, from the Department of General Services.

Location of existing units




YELLOW- Three (3) Model: YHC120F3ELA-A0B1


RED- One (1) Model: TSC120F3ENA-A0B1

Contractor must deliver and maintain such insurances as provided; failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

Successful bidder will be required to procure standard insurance policies evidencing Parish mandated insurance requirements indicated below. The current certificate of insurance must be submitted by low bidder within 10 days after bid opening to the Purchasing Department. Failure to comply will cause bid to be rejected.
