## Your Community – Jefferson Parish

OBH has intensive outpatient programs ready to address the needs of juveniles and their families in Jefferson Parish who are engaged in the juvenile justice system and have underlying mental health disorders. Our Marrero location provides adolescent intensive outpatient treatment. Our Kentwood location can provide inpatient services to adolescents if the need is determined. OBH in Marrero and Kentwood are prepared to meet the needs of adolescent services for Jefferson Parish.

OBH maintains a strategy of growth through scaling upon needs. OBH works with its partners and clients to provide treatment proportional to needs.

Oceans Behavioral Hospital Marrero is one of three Oceans Behavioral Hospitals in the Greater New Orleans area. Our hospital administrator is Allen McCartney, FACHE. Allen has fifteen years of experience in mental health administration.

What begins as a referral from the juvenile court, becomes a pathway of services specialized in accordance with the needs of the individual and consideration of the family. ## From Court to Care

The Jefferson Parish Juvenile Court when partnered with OBH will be able to access mental health services in our intensive outpatient program setting. Regular communication between the treatment team, designated court personnel and the judge will occur so that the progress is documented and provided. As prescribed by the Jefferson Parish Juvenile Court, data concerning the individuals in treatment and the overall program will be collected and provided to allow for oversight and ensure the program's success. This will allow the court to analyze the impact of treatment on recidivism, school performance, family functioning and aggressive incidents.

## Proposed Solution

OBH Hospitals are prepared to partner with the Jefferson Parish Juvenile Court to provide better outcomes for juveniles who are engaged in criminal misbehavior resulting from underlying mental health disorders. When mental health disorder is addressed holistically through an effort that includes the court, appropriate providers, the schools, the families and most importantly the juvenile a reduction of negative actions and results can occur.

Oceans Behavioral Hospitals are working with other courts throughout Louisiana to divert people with mental health disorders out of the criminal justice system. This can occur through a relationship between Jefferson Parish Juvenile Court and Oceans Behavioral Hospitals.

The *Scope of Work* would be designed specifically for the Jefferson Parish Juvenile Court. Components will include, but are not limited to:

1. Receiving referrals from the Departmental Evaluation/Treatment Supervisor.
2. Upon receipt of the referral, OBH will initiate contact with clients (juveniles and their families).



3. Preparation and execution of agreements of confidentiality and release of information so that all protected patient information is handled in accordance with the law.
4. Written results of clinical evaluations along with recommended treatment plans.
5. Receipt of formatted referrals from the court directing a juvenile to engage in services.
6. OBH will schedule with the client and families and begin treatment program(s). OBH will provide formatted progress reports and other data measures as specified by the court that provides for individual participant updates and overall program measures. OBH Hospitals will work with Jefferson Parish to develop a system to collect, measure, and provide outcomes of all patients referred for treatment. This will include insuring that all appropriate consent forms and releases are executed so that all protected health information is handled in accordance with law. The courts and designated personnel will be provided with information so that understanding of the individual client's status and the overall program goals are being met.
7. OBH will schedule program meetings where members of the court and Oceans Behavioral Hospital staff meet to discuss any identified issues with the program.
8. OBH will insure that all OBH personnel continually receive training relevant to all program and treatment services.
