- (2) Bids shall be submitted at centralbidding.com or in *sealed* envelopes clearly marked with Bidder's name and "Bid 17-15: Sale of Surplus Buses" on the outside of envelope.
- (3) A \$100.00 Bid Security is required. Bid Security must accompany bid proposal; it cannot be submitted after the bid has been opened.
- (4) Award will be granted at the April 4, 2017 Rapides Parish School Board meeting to the highest Bidder(s) on a line item basis. Successful bidder(s) will be notified the day after award certified U.S. Mail.
- (5) Payment for items purchased shall be in the form of a cashier's check or money order made payable to the Rapides Parish School Board. **PERSONAL CHECKS AND CASH WILL NOT BE ACCEPTED.** Terms of sale is "as is where is".
- (6) **ALL ITEMS MUST BE PICKED UP BY May 10, 2017 close of business unless other prior arrangements have been made** or your bid will be deemed in default and you forfeit your bid security, not as earnest money but as liquidated damages for your default or nonperformance. - (7) **Buses shall be removed in their "as is" condition. No dismantling or modifying of the buses is to occur on site.**
