Section 1.0 – Pre-Bid Conference:

A Pre-Bid Conference will not be necessary.

Section 1.1 – Louisiana State Contractor's License Requirements

Class – Plumbing (Statewide)

Section 2.0 – Scope:

We extend this proposal to cover all labor, materials, and necessary essentials to remove and replace broken pipe at West Bank Recreation Main Office

Section 3.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 4.0 – Bid Specifications:

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at **Westbank Recreation, 7437 Lapalco Blvd, Marrero, La 70072 as described**

A. Filing:

1. Vendor shall be responsible for filing necessary paperwork to perform tunneling and excavation at work site.

B. Tunneling

1. Dig 3' x 3' base hole by the left side of the building to gain access to under-slab plumbing.

C. Removal and Replacement

1. Hand dig under slab from base hole to expose main sewer line, kitchen line, and lines to men's and women's restrooms.
2. Remove main sanitary line under slab piping with break for the kitchen and restrooms and replace with new PVC pipe and fittings and route to existing main sewer line to the lift station

3. Install stainless steel repair hangers to stabilize and secure pipe under slab.
4. Backfill all exposed excavated areas using existing soil and clean area to "before job" conditions.

D. Estimate Conditions

1. Estimate given is for what is able to be verified from an on-site visit. If conditions exist that are not listed in the estimate, additional charges may apply.

Section 5.0 – Cleaning Area and Safety:

Contractor must perform daily housekeeping on work area and removal of job debris

Section 6.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Installation Conference shall be held between the successful bidder and the owner before any work commences.

Section 7.0 – Construction Term

Upon receiving a notice to proceed, the Bidder agrees that all work shall be completed as follows: Vendor agrees to commence actual physical work on the site with an adequate force and equipment within 10 days from the date of Notice of Proceed. All work shall be substantially completed in **NINETY (90)** consecutive calendar days from date of Notice to Proceed.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected.
