This is for a two year uniform contract for Jefferson Parish EastBank Consolidated Fire Department.

Vendor shall be responsible for sizing of personnel at various fire station locations within the EastBank Consolidated Fire Department protection district.

Vendor shall have available uniforms for personnel to try on for fit at time of sizing.

Vendor shall be responsible for all alterations with no cost to department or personnel.

Vendor shall provide name tape with embroidery to tactical shirts.

Vendor shall provide the American flag (reverse flag) to be sewn on to dress shirts and jackets on the right shoulder.

Vendor shall provide embroidery upon request to polo shirts and uniform shirts.

Vendor shall package all uniform orders with name of personnel to the outside of bagon labels.

The Fire Department personnel will use a voucher system to purchase uniforms; successful vendor will be required to administer this program. See page two (2) for further information regarding the voucher system.

After said vouchers are fully expensed per the requirements on page 2, successful vendor shall sell to Jefferson Parish Fire Department personnel of individual purchases at the bid price on cash sales.

Vendor shall provide thirty-six (36) hour turn around on alterations and uniform replacement.

Jefferson Parish Fire Department shall supply the fire department patch to be sewn on by vendor to uniform jacket, dress shirts, and tactical shirts.

Successful Vendor shall maintain and provide for an electronic voucher/ledger system and upon request, produce electronic records of all Jefferson Parish Fire Department purchases made on behalf of each of its personnel during the contract period. Additionally, specific invoices and individual item(s) purchased from within the voucher/ledger system shall be provided upon request.

Successful vendor must demonstrate to the Jefferson Parish Fire Department that safeguards are in place to prevent unauthorized purchases from being charged to the Jefferson Parish Fire Department during the contract period. The voucher system should not prevent individual personnel from buying uniform contract items with payment other than voucher funds ("cash sales"). However, the accounting of voucher purchases shall be distinguished from cash sales purchases.

Successful vendor shall have the capability of receiving electronic notification for purposes of increasing or otherwise modifying the voucher status/balance of each person. Successful vendor must be able to electronically acknowledge these modifications to the Jefferson Parish Fire Department.

The successful vendor shall be responsible for providing Jefferson Parish Fire Department with the following:

1. An invoice as backup to each purchase to include (minimum information):
  1. Voucher number
  2. Individual's full Name
  3. Individual's Social Security number or employee number

2. A comprehensive listing to include Jefferson Parish Fire Department Personnel (each of its individual personnel), a starting voucher sum, amount of voucher used and balance of voucher available, with the ability to incorporate voucher increases during the contract period.
3. Electronic records of all Jefferson Parish Fire Department purchases made during the contract period. Additionally, specific invoices and individual items purchased shall be provided to Jefferson Parish Fire Department upon request.
4. Vendor shall have the capability of receiving electronic (e-mail) modifications to the individual's account status and the capability of acknowledging these modifications

Stays to be 2-1/2" long, 3/8" minimum width, and to be fused to underside of collar interlining. Stays applied directly to collar material itself unacceptable. Topstitched 1/8" off the edge. Collar material itself (top or underside) shall have no fusing to Mylar stays or collar interlining.

### **FRONT:**

Each front shall have a facing approximately 3" in width. The right front shall have a top center placket 1-1/2" wide with two rows of stitches 7/8" apart. Stitching on the top center is not to be visible on the turn back facing. The shirt will have 6 buttons and buttonholes on the front; spacing between each will be 3-1/2" except the spacing between the neck button and the first button on the front, which will be approximately 2- 1/2". Top center interlined with #250 Dacron. Non-woven interlining unacceptable and shall be cause for rejection. The fronts shall be joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a 1-1/2"

raised stitch. Safety stitch joining unacceptable.

## **Women's Shirt Specifications**

### **SHOULDER STRAPS:**

Shoulder straps to be two-piece pointed, 1/8" topstitched and to be set on yoke with leading topstitch conforming to front joining seam. To measure 2" at sleeve tapering to 1-3/8" and set not more than 1/2" from collar set seam. Cross-stitched approximately 2" from sleeve seam. Shoulder strap to have functional buttonhole to attach to sewn button on shoulder of shirt. Edge stitched shoulder strap construction unacceptable.

### **BADGE REINFORCEMENT:**

Two-ply sling 1" wide centered over left pocket and stitched to shoulder seam and flap setting stitch. It shall have 2 (two) buttonhole eyelets 1-1/4" from top of pocket flap spaced 1-1/4" apart and centered on sling.

### **POCKETS:**

Two breast patch pockets with mitered corners and 1-1/4" stitched pleats. Pleats shall be stitched top and bottom and full length of pleat to prevent spreading. Pocket to measure 5" wide, 5" deep. Each pocket to have hook Velcro, 3/4" long by 1/2" wide, positioned on both edges of pocket to correspond with outer scalloped flap points as specified. Velcro to be stitched all sides and to be sewn through pocket and shirt for added reinforcement.

### **FLAPS**

Two-piece deep scalloped design to measure 5-1/4" across and 2-1/4" in depth at center point, 1-3/4" at sides. Secured to shirtfront approximately 3/8" above pocket. Left flap to have invisible pencil opening 1-1/4". (Stop & start stitching for pencil opening unacceptable and shall be cause for disqualification.) Flaps to be 118 topstitched. measure 1-1/8" wide point blocked at top.

the neck button and the first button on the front, which will be approximately 3-1/4". Top center placket to have woven interlining of #250 Dacron. Non-woven interlining unacceptable and shall be cause for rejection. The fronts shall be joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a 1/16" raised stitch. Safety stitch joining unacceptable.

### **SHOULDER STRAPS:**

Shoulder straps to be two-piece pointed, 1/8" topstitched and to be set on yoke with leading topstitch conforming to front joining seam. To measure 2" at sleeve tapering to 1-3/8" and set not more than 1/2" from collar set seam. Cross-stitched approximately 2" from sleeve seam. Shoulder strap to have functional buttonhole to attach to sewn button on shoulder of shirt. Edge stitched shoulder strap construction unacceptable.

### **BADGE REINFORCEMENT:**

Two-ply sling 1" wide centered over left pocket and stitched to shoulder seam and flap setting stitch. It shall have 2 (two) buttonhole eyelets 1-1/4" from top of pocket flap spaced 1-1/4" apart and centered on sling.

### **POCKETS**

Two breast patch pockets with mitered corners and 1-1/4" stitched pleats. Pleats shall be stitched top and bottom and full length of pleat to prevent spreading. Pocket to measure 5-5/8" wide, 6" deep. Left breast pocket to have 1-1/2" pencil stitch. Each pocket to have hook Velcro, 3/4" long by 1/2" wide, positioned on both edges of pocket to correspond with outer scalloped flap points as specified. The trouser styling shall be T-1: plain front, two (2) quarter top front pockets, and two (2) hip pockets professionally finished with no visible topstitching. Work wear industrial style construction is unacceptable and shall be cause for disqualification.

### **LINING MATERIAL:**

The pocketing and fly lining material shall be 70% Polyester / 30% Cotton, 2.9 oz. per square yard (60" width) with a minimum 78 x 48 count. Pocketing must have a durable press finish and the color of the pocketing must be black.

### **FREEDOM-FLEX WAISTBAND SYSTEM OR EQUAL:**

Trouser shall be made with a special Freedom-Flex Waistband System that will allow the wearer waist expansion of 2-1/2" to 3". The waistband shall measure a minimum of 1-7/8" wide when finished. The flexible expansion split portion of the waistband shall be to the front of the trouser side seam and there shall be an inch wide side belt loop positioned to 'hide' the expansion split of the waistband.

The waistband curtain shall consist of two different styles for maximum waistband expansion to enhance wearer comfort, fit, and appearance. The front of the trouser (to the expansion split) waistband curtain style shall consist of a 2-inch wide elastic section that incorporates Tru-Grip, a 1/2" surface area composed of thin 55 gauge rubber for maximum comfort and performance. The Tru-Grip acts to help keep shirts tucked in securely. (Use of a single silicone strip or strips instead of 1/2" wide rubberized surface area shall be cause for disqualification.)

The back half of the trouser waistband curtain shall finish a minimum 2-1/8" wide

and is to be made of black pocketing material and shall be attached to the top of the trouser with a zigzag stitch. The waistband curtain must also contain Tru-Grip and will line up with the Tru-Grip on the front of the expansion split. (Substitution of a silicone strip or strips in place of Tru-Grip shall not be acceptable and shall be cause for disqualification.)

The waistband curtain is composed of a wet laid non-woven canvas weighing 3.3 oz. per square yard. The canvas is covered in the same color and material as the pocketing. The ½" rubberized surface area is positioned 1-1/2" up from the bottom of the curtain.

To complete the Freedom-Flex Waistband System, there shall be a 1-1/4" wide elastic component sewn into the back half of the waistband curtain to allow for the stretch and recovery of the waistband to comfortably fit the wearer's waist size. There shall be a bartack for strength and durability sewn at the stress point on the waistband where it joins the front elasticized waistband curtain joining stitching (positioned, on the waistband above the front pocket.)

The waistband closure shall be accomplished with a single crush proof hook and eye centered on the waistband for wearer comfort. The hook and eye shall be reinforced with a 7/8" non-woven tape that is anchored with topstitching through and through to the top of the waistband (bartacks in place of topstitching shall be cause for disqualification). In addition to the stitching of the waistband when it is set onto the trouser, the waistband must also be topstitched below the waistband seam of the trouser to be finished to allow for alterations (with ample fabric and curtain material to allow trouser size to be increased at least one size). The outlet in the seat is to be proportional to the waist outlet so the seat may also be let out. Seat seam must be sewn with a tandem needle machine (double-needle stitch) for maximum stretch.

## **BELT LOOPS:**

There shall be a minimum of seven belt loops 3/4" in width of double thickness. Each loop must have a non-woven interlining for added durability. All loops (except back center) must be sewn into the top and bottom of the waistband ("dropped" belt

loops that are tacked to the outside of the trouser all around waist shall be cause for disqualification). The top of the belt loops (except back center) shall be sewn into the waistband curtain seam with a Rocap machine using a zigzag stitch. The bottom of the center back loop shall be tacked to the trouser and the top of the loop tacked to the outside of the waistband to allow for easier waist alteration.

### **FLY:**

Trouser shall have a brass metal zipper with memory lock brass slider secured by metal stopper at base. There shall be a French Fly tab closure on the inside of the right fly. The tab shall be double ply made of the basic trouser fabric (tabs made of pocketing material or a "grown on" French Fly will be cause for disqualification). The right fly shall be lined with the same material and color as the pocketing. Seat must be sewn with a Tandem Needle Machine (double-needle stitch) for maximum durability.

added durability. There shall be a dart centered above each hip pocket to waistband. Dart shall be approximately 2-3/4" long tapered from 3/8" at waistband and shall be installed with automatic equipment for a clean non-puckered finish.

The watch pocket shall be located on the right front at the waistband. This pocket shall have a minimum opening of 2-5/8" and a minimum depth of 2-7/8". The front of the pocket shall be made of pocketing fabric and the back of the pocket shall be made of basic fabric and the two pieces are securely stitched together. Each corner of the pocket opening shall have firm straight bartacks.

### **CREASES:**

The leg creases, front and back will have a silicone bead put in by using the Lintrak process.

### **STITCHING. PRESSING & FINISHING :**

**GENERAL DESCRIPTION:** A highly engineered trouser designed for fire service applications to maximize the appearance and wear life potential of a precisely dyed fabric of proven long-term reliability. The Poly/Cotton trouser is designed to assure consistency of construction and fit across the full range of firefighter body types.

**FABRIC:** Trouser shall be manufactured with the following fabric to assure absolute consistency of color and performance. Fabric is vat dyed for ultimate color retention.

Blend: 65% Polyester /35% Cotton

Weight: 7.75 oz.yd<sup>2</sup>

Blend: Pre-cure wrinkle resistant /soil release

Color: Midnight Navy

Thread: Thread is cotton wrapped on a monofilament polyester core

**DESIGN:** Trousers shall be made on a full cut uniform pattern. The trousers shall incorporate a plain front, two (2) front pockets and two (2) rear hip pockets.

**BOTTOMS:** Trousers shall have unfinished bottoms.

Unfinished inseam lengths: 37 ½"

Tall 38 1/2"

**INTERNAL CONSTRUCTION FABRIC:** Pockets and waistband shall be black 65% Polyester / 35% Cotton. Front pocket bottoms reinforced (3.5") with a second layer of pocketing for increased abrasion resistance. Two strips of red silicone shirt grip beading around the waistband.

## **JEFFERSON PARISH FIRE DEPARTMENT STATION WEAR TROUSER**

**SIZING:** The Poly/Cotton trouser pattern is fully graded such that all vital dimensions change according to waist size. The grade applies to seat, front rise, back rise, thigh, knee and bottom opening measurements. Certain critical dimensions for men's regular rise trousers are as follows:

TALL: ADD ½" to front and back rise, with 38" unfinished inseam.

**STITCHING:** All thread tension is evenly maintained to eliminate tight or loose stitching. All seam allowances are maintained so that there are no raw edges, run offs, twists, pleats, puckers, or open seams.

**SLIDE FASTENER:** Slide fastener (fly zipper) shall consist of solid brass hardware on colorfast nylon 7/16" tape. Chain size #45Y. Style 45YGS5 slider and ratcheting chain to prevent breakage of chain teeth.

**WAIST CLOSURE:** Primary waist closure is two hooks and bars construction, mounted on the waistband using rustproof nickel plated steel hardware as follows: Size 85 bar and bar internal reinforcement plate. Size 8 hook and hook internal reinforcement plate. Internal reinforcement tape 7/8" wide shall be mounted between the plates and the body fabric to insure construction integrity for extended wear life.

**TAILORED WAISTBAND:** The waistband is full dress style including all tailoring detail of construction. It is assembled from internal construction fabric to finish 2" wide with 1/4" extension. Approximately 2" of additional waistband length shall be turned at the center back seam to permit alterations of up to 1" in the waistband and up to 1" through the seat. The entire circumference of the waistband is permanently set with two rows of red silicone beading to enhance a neat appearance by preventing shirt pull-out at the waist. After assembly the waistband is Ro-Cap™ set to the trouser. Grown on waistlines are not acceptable in lieu of trouser waistband as they add no strength or shape to the garment.

**BELT LOOPS:** There are seven belt loops on waist sizes 30" through 45", nine loops on waist sizes 46" and over, and five loops on sizes 28" and 29". Belt loops shall be set into the waistband at the top and bottom. Belt loops are fully 2 1/4" long and have a finished width of 3/4".

**TAILORING AT HIPS:** There are two darts to shape the trouser at the hips. They are placed at the left and right back extending down from the waistband to the center of each hip pocket

**POCKETS:** There are four pockets as follows:

**FRONT:** Left and right bi-swing type pockets with 6 1/2" quarter top openings and fully 1 1/4" depth. Openings are triangle bar-tacked reinforced at top inside waistband and at bottom across side seam. Pockets are also bar tacked twice at top of pocket bag under waistband, at corner of pocket bag, and at side seam. Pocket bags are reinforced by doubling pocket weight at the bottom of pocket bags. Pockets are constructed of internal construction fabric, not less than 2 1/2" deep.

**REAR:** Left and right bi-swing type hip pockets of top and bottom welt construction with openings 5 1/4" wide and 6" deep. Pocket openings shall be topstitch, reinforced openings and triangle bar tack reinforced at both ends for greater strength. Left pocket opening shall include # 22 ligne black four, with a button tab for closure

## **JEFFERSON PARISH FIRE DEPARTMENT STATION WEAR TROUSER**

**FLY CONSTRUCTION:** The right inside fly is reinforced with internal construction fabric and 1/8" gauge topstitched along the entire exposed edge to insure shape retention for extended wear life. The left, outside fly is fully lined internally for shape retention on. Right and left fly are joined together at the base of the fly and this joint is reinforced through all layers of fabric with three bar tacks and an extended fly tail. The extended fly tail extends past the crotch seam by 1" for additional strength. The first bar tack is set horizontally. The second is set above the first and at a 45 degree angle. The third is set at a 45 degree angle in line with the first bar tack. The right inside fly is a true French Fly with secondary button closure for additional reinforcement and smooth appearance.

**CROTCH AND SEAT ASSEMBLY METHOD:** The crotch is formed below the fly at the intersection of the four foundation panels of the trouser: Left front, right front, left rear and right rear. Two triangular pieces (crotch lining) are sewn into the two front panels of the trousers to help absorb perspiration and increased strength to crotch seam. The trouser is assembled to form this crotch by first sewing the left front to the left rear thus making the left side of the trouser; and the right front to the right rear to form the right side. The left side of the trouser thus formed is then joined together to the right side by means of the seat seam. The trouser is not assembled by the alternate whole front to whole back method due to the unreliability of that method during extended wear life.

**SEAT CONSTRUCTION:** Extra fabric is allowed such that seat girth and waistband diameter may be expanded or decreased by the wearer during the trouser's extended wear life.

**SILICONE CREASING:** Permanent creases are applied by applying a row of silicone to the center front and center back of each pant leg.

**FINISHING:** All Poly/Cotton trousers shall be pressed and creased for a uniform appearance.

**LABELING:** All trousers will bear all labels mandated by the Federal Trade Commission at the date of manufacture.

**FABRIC:**

### **STYLE:**

Trouser shall be manufactured from an up-to-date men's uniform trouser pattern. The trouser styling shall be T-1: plain front, two (2) quarter top front pockets, and two (2) hip pockets professionally finished with no visible topstitching. Work wear industrial style construction is unacceptable and shall be cause for disqualification.

### **LINING MATERIAL:**

The pocketing and fly lining material shall be 70% Polyester / 30% Cotton, 2.9 oz. per square yard (60" width) with a minimum 78 x 48 count. Pocketing must have a durable press finish and the color of the pocketing must be black.

**FREEDOM -FLEX WAISTBAND SYSTEM:**

Trouser shall be made with a special FreedomFlex Waistband System that will allow the wearer waist expansion of 2 1/2" to 3". The waistband shall measure a minimum of 1-7/8" wide when finished. The flexible expansion split portion of the waistband shall be to the front of the trouser side seam and there shall be a 5 inch wide side belt loop positioned to 'hide' the expansion split of the waistband.

The waistband curtain shall consist of two different styles for maximum waistband expansion to enhance wearer comfort, fit, and appearance. The front of the trouser (to the expansion split) waistband curtain style shall consist of a 2-inch wide elastic section that incorporates Tru-Grip, a W' surface area composed of thin 55 gauge rubber for maximum comfort and performance. The Tru-Grip acts to help keep shirts tucked in securely. (Use of a single silicone strip or strips instead of 1/2" wide rubberized surface area shall be cause for disqualification.) The back half of the trouser waistband curtain shall finish a minimum 2-1/8" wide and is to be made of black pocketing material and shall be attached to the top of the trouser with a zigzag stitch. The waistband curtain must also contain Tru-Grip and will line up with the Tru-Grip on the front of the expansion split. (Substitution of a silicone strip or strips in place of Tru-Grip shall not be acceptable and shall be cause for disqualification.)

The waistband curtain is composed of a wet laid non-woven canvas weighing 3.3 oz. per square yard. The canvas is covered in the same color and material as the pocketing. The 1/2" rubberized surface area is positioned 1-1/4." up from the bottom of the curtain.

**MEN'S TROUSER SPECIFICATION**

The specifications for the rubberized Tru-Grip curtain are as follows:

To complete the Freedom-Flex Waistband System, there shall be a 1-1/4" wide elastic component sewn into the back half of the waistband curtain to allow forth stretch and recovery of the waistband to comfortably fit the wearer's waist size. There shall be a bartack for strength and durability sewn at the stress point on the waistband where it joins the front elasticized waistband curtain joining stitching (positioned, on the waistband above the front pocket.)

The waistband closure shall be accomplished with a single crush proof hook and eye centered on the waistband for wearer comfort. The hook and eye shall be reinforced with a 7/8" non-woven tape that is anchored with topstitching through and through to the top of the waistband (bartacks in place of topstitching shall be cause for disqualification). In



addition to the stitching of the waistband when it is set onto the trouser, the waistband must also be topstitched below the waistband seam of the trouser to be finished to allow for alterations (with ample fabric and curtain material to allow trouser size to be increased at least one size). The outlet in the seat is to be proportional to the waist outlet so the seat may also be let out. Seat seam must be sewn with a tandem needle machine (double-needle stitch) for maximum stretch.

**BELT LOOPS:**

There shall be a minimum of seven belt loops 3/4" in width of double thickness. Each loop must have a non-woven interlining for added durability. All loops (except back center) must be sewn into the top and bottom of the waistband ("dropped" belt loops that are tacked to the outside of the trouser all around waist shall be cause for disqualification). The top of the belt loops (except back center) shall be sewn into the waistband curtain seam with a Rocap machine using a zigzag stitch. The bottom of the center back loop shall be tacked to the trouser and the top of the loop tacked to the outside of the waistband to allow for easier waist alteration.

**FLY:**

Trouser shall have brass metal zipper with memory lock brass slider secured by metal stopper at base. There shall be a French fly tab closure on the inside of the right fly. The tab shall be double ply made of the basic trouser fabric (tabs made of pocketing material or a "grown on" French fly will be cause for disqualification). The right fly shall be lined with the same material and color as the pocketing. The fly lining shall be sewn to the left fly continuing below the zipper into the crotch area in a neat and durable manner. A button shall be located on the left fly corresponding with the French fly tab to provide a clean and comfortable closure. Topstitching of fly to be installed with automatic "J" stitch equipment eliminating puckering and providing a clean finish. There shall be a firm straight bartack at the bottom of the fly going through the zipper tape for maximum strength. Bartack shall line up with starting point of "J" stitch.

**SEAT:**

Seat must be sewn with a Tandem Needle Machine (double-needle stitch) for maximum durability.

**MEN'S TROUSER SPECIFICATION****POCKETS:**

The two (2) front pockets will be quarter top style with a minimum opening of 6" and a minimum depth of 5-3/4" measured from the bottom of the opening. Front pockets to have firm straight bartacks at top and bottom of pocket openings. Pockets shall be constructed using the stitch, tum, and topstitch method. Front pocket facing and barrier to be made of the basic trouser fabric. Facing shall be a minimum of 1" and barrier

shall measure a minimum of 2" (measured to the inside edge of pocket lining).

The two (2) hip pockets shall have a minimum 5-3/8" wide (bartack to bartack) opening and a minimum depth of 5-3/4 " measured from the bottom of the pocket opening. Hip pockets shall be constructed using the double welt method on an automatic welt machine. The welts shall be finished in such a manner that there is no topstitching (topstitched hip pockets shall be cause for disqualification). The corners of the hip pocket openings shall have triangular bartacks for reinforcement (use of straight bartacks shall be cause for disqualification). Hip pocket facing and barrier are to be made of basic trouser fabric. Facing shall be a minimum of 3/4" and the barrier shall be a minimum of 1-1/2". The left hip pocket shall have a centered tab made of basic cloth inserted into the top welt with bartacks at the top and bottom of the tab to form an opening for a button. A button shall be located below the bottom welt corresponding in location with the tab, which shall be interlined with non-woven for added durability. There shall be a dart centered above each hip pocket to waistband. Dart shall be approximately 2-3/4" long tapered from 3/8" at waistband and shall be installed with automatic equipment for a clean non-puckered finish.

The watch pocket shall be located on the right front at the waistband. This pocket shall have a minimum opening of 2-5/8" and a minimum depth of 2-7/8". The front of the pocket shall be made of pocketing fabric and the back of the pocket shall be made of basic fabric and the two pieces are securely stitched together. Each corner of the pocket opening shall have firm straight bartacks.

#### **CREASES:**

The leg creases, front and back will have a silicone bead put in by using the Lintrak process.

#### **STITCHING, PRESSING & FINISHING:**

Trouser must be stitched with matching thread. Trouser must be neatly pressed on Hothead Presses and properly shaped. Out seams and inseams is edge surged on automatic equipment for uniformity of quality and shall be pressed open for a smooth pucker-free finish with repeated cleaning and pressing. Trouser must be cleaned and finished to eliminate loose threads.

#### **LABELS:**

Trouser must have a permanent label providing care instructions and small woven label indicating waist size. A removable paper ticket showing the size, fabric content, cut number, and WPL or RN number must be on the outside of the waistband. Ticket to be matchbook style installed with plastic staples for easy removal without damaging trouser material and showing size when trousers are stacked.

### **BADGE TAB:**

Separate loop badge tab made of cloth about 2 1/4" long with two (2) stitched eyelets, about 1 1/8" apart, sewn to the outside left breast of the coat.

**EMBLEMS:**

There shall be a department furnished emblem sewn on the left sleeve of the coat 1" down from shoulder seam and centered.

**SWEATSHIELDS:**

A sleeve sweat shield of the same cloth as in the body of the coat, piped with rayon to be securely set under each arm over the lining.

**BUTTONHOLES:**

All buttonholes shall be made to a full *W* from the edges of the seam. The ends of all buttonholes shall be bartacked. All buttonholes to be "cut after" machine made buttonholes. All thread used in making buttonholes shall be black silk, tailor's button twist, colorfast and guaranteed against fading.

**OUTLETS:**

All body seams to have outlets of not less than 1". Turn up at sleeve cuffs to be no less than 2 1/2".

**LABELS:**

Must have care label permanently affixed; must also have size, label showing fiber content. Garment must be made in the United States of America and bear a union label.

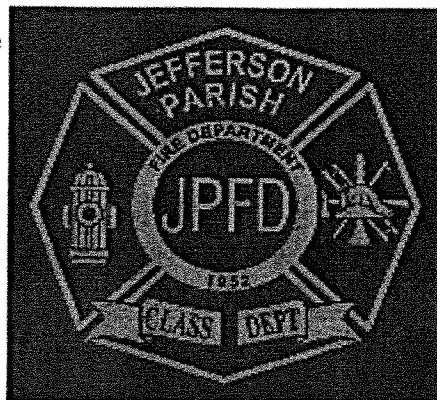

65% polyester and 35% cotton, Poplin weave, 5.0 oz. per yard from Milliken & Co., soil release and moisture wicking finish.

#### **FRONTS**

Left front to have a self-fabric center pleat 1 1/2" wide extending from collar band to bottom of shirt held down with two rows of stitching 7/8" apart. The center pleat to be lined with 100% polyester, 250 denier. Right and left fronts to have an approximately 3" turn back extending from collar to bottom of shirt. There shall be six front and one collar button. The shirt is to have sewn in permanent military creases. 1 in each front and 3 in the back.

#### **COLLAR**

The collar is to be die cut. Convertible collar is to measure 3 1/4" long at points and topstitched 1/4" from edge. The interlinings are to be 100% polyester. Permanent collar stays of proper length are to be sonic fused to underside of interlining.

**INSURANCE REQUIREMENTS - BIDS**

All insurance requirements shall conform to Jefferson Parish Resolution No. 113646 or No. 113647. The contractor shall not commence work under this contract until he has obtained all insurance and complied with the requirements of the specifications and said Parish Resolutions. Except as otherwise provided by law, the Parish Attorney's Office with the concurrence of the Director of Risk Management is authorized to omit in whole or part the insurance requirements of this section in connection with contracts. Vendors inquiring about this shall submit his written request to the Purchasing Department prior to the due date of the bid. Contractor must deliver and maintain such insurances as provided; failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

*Successful bidder will be required to procure standard insurance policies evidencing Parish mandated insurance requirements indicated below. The current certificate of insurance must be submitted by low bidder within 10 days after bid opening to the Purchasing Department. Failure to comply will cause bid to be rejected.*

**1. WORKER'S COMPENSATION INSURANCE**

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

**2. COMMERCIAL GENERAL LIABILITY**

Unless otherwise specified in the bid, these additional insurance is required. Such insurance is due upon contract execution.

**OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

**BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
