Questions & Answers

Question 1: Item 16: Would an equivalent, substitute be acceptable? This product is not worn against the skin and should not cause an allergic reaction.

Answer 1: Most substitutes cannot be accepted due to the differences in ingredients and size. The requesting department only orders items with a clear list of ingredients and specific sizes to ensure quantities align with our budget requirements.

Question 2: What is the expected delivery timeframe?

Answer 2: The expected delivery timeframe is 1-2 weeks.

Question 3: When is the bid start date?

Answer 3: The exact start date cannot be determined, as the bid must be tabulated and receive the necessary approvals following the bid opening before being awarded to the vendor.

Question 4: I wanted to double check on whether this was an all or none bid request or will it be awarded by line item?

Answer 4: A line item can be considered; however, it is unlikely to be accepted due to the challenges of using multiple vendors for similar items such as diapers, wipes, and etc. It is preferable for us to award all items with a single vendor. However, a vendor who offers the majority of the items, we may consider moving forward with them.

Question 5: If an item is discontinued by manufacturers, should we quote the successor product with a note?

Answer 5: Yes, if an item is discontinued by manufacturers vendors should quote the successor product with a note specifying the brand name and stock number.

This bid has been postponed until March 18, 2025.

In the event the Office of Apprenticeship Training, Employer and Labor Services, or a State Apprenticeship Agency recognized by the Office, withdraws approval of an apprenticeship program, the contractor will no longer be permitted to utilize apprentices at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

(ii) Trainees. (2) *Subject invention* means any invention of the *contractor* conceived or first actually reduced to practice in the performance of work under this *contract*, provided that in the case of a variety of plant, the date of determination (as defined in section 41(d) of the Plant Variety Protection Act, 7 U.S.C. 2401(d)) must also occur during the period of *contract* performance.

chemical, biological or electrical characteristics of the invention. The disclosure shall also identify any publication, on sale or public use of the invention and whether a manuscript describing the invention has been submitted for publication and, if so, whether it has been accepted for publication at the time of disclosure. In addition, after disclosure to the *agency*, the *Contractor* will promptly notify the *agency* of the acceptance of any manuscript describing the invention for publication or of any on sale or public use planned by the *contractor*.




