## CHANGES TO JEFFERSON PARISH BIDDING PROCEDURES

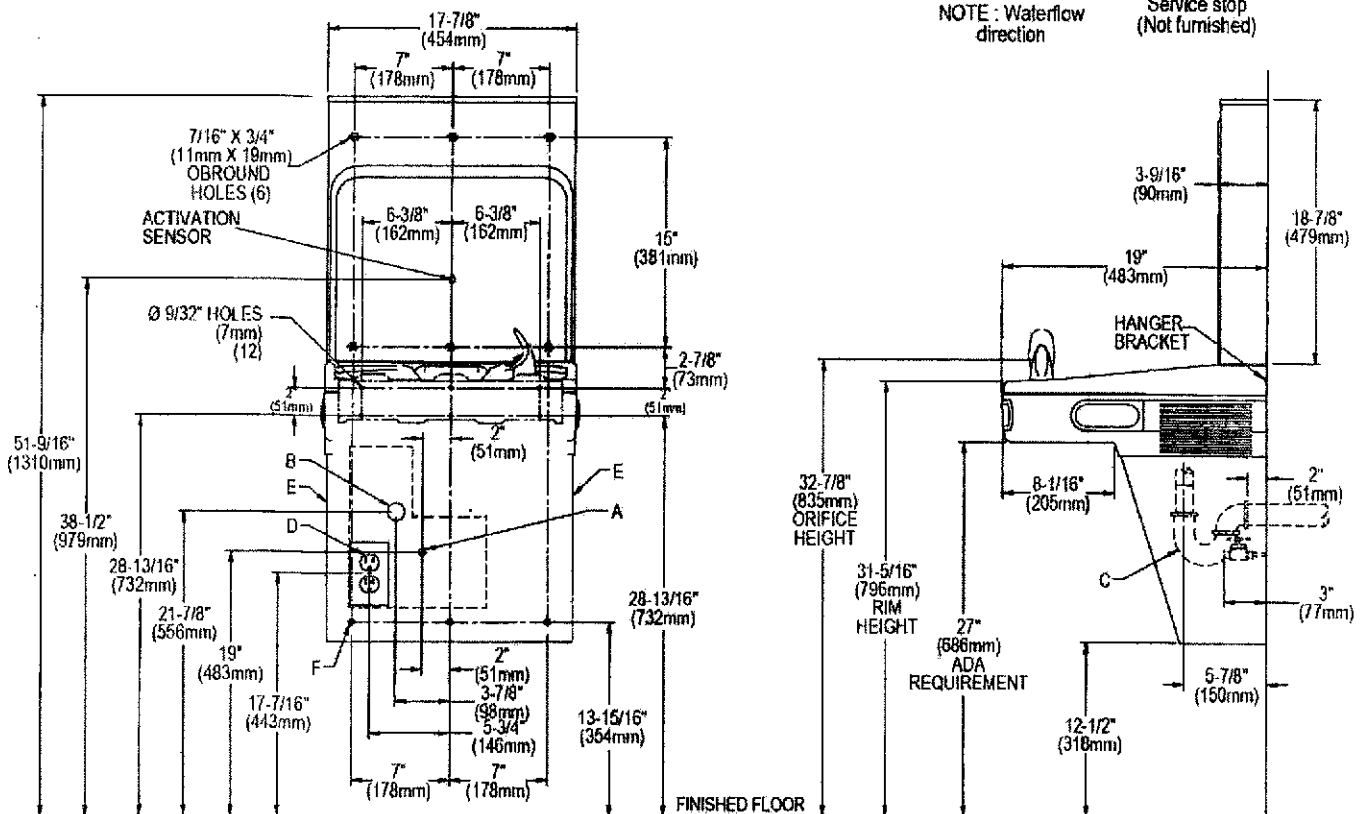
