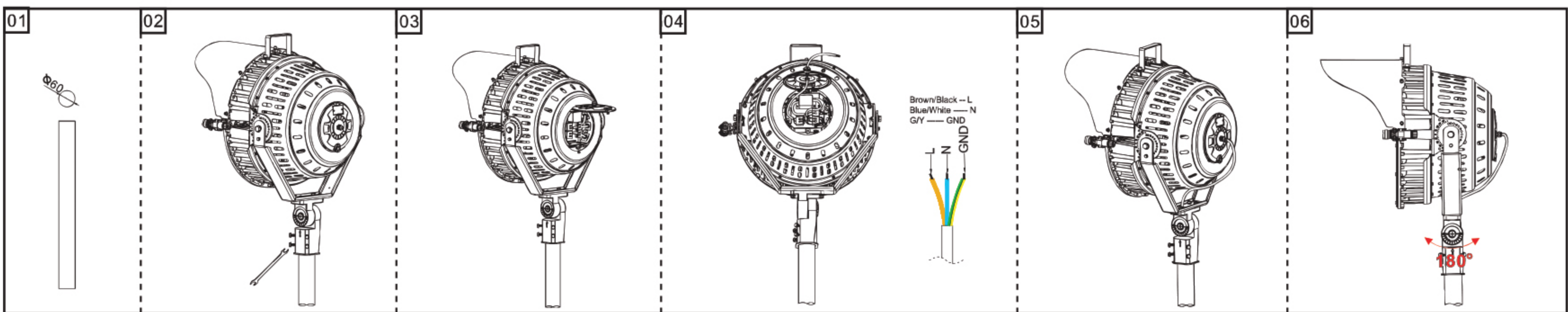
P1 U-Shaped Bracket



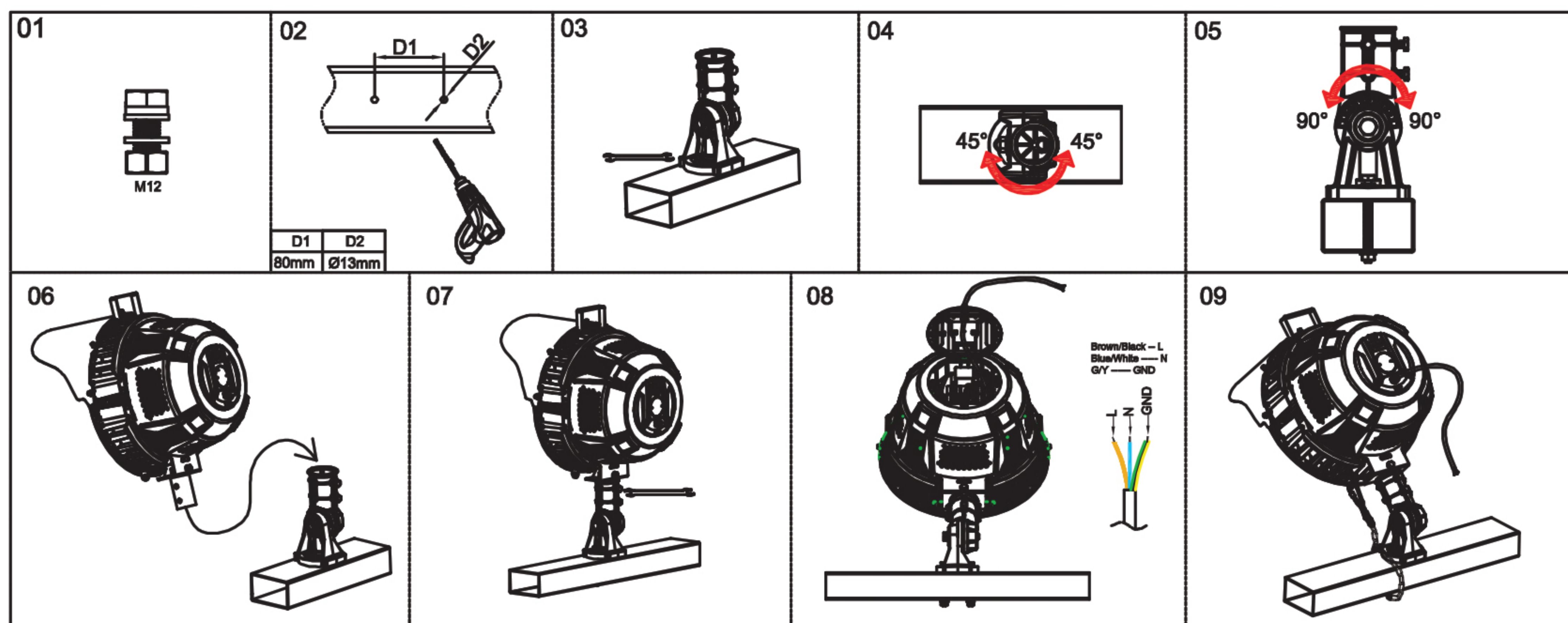
P2 Rotatable Bracket



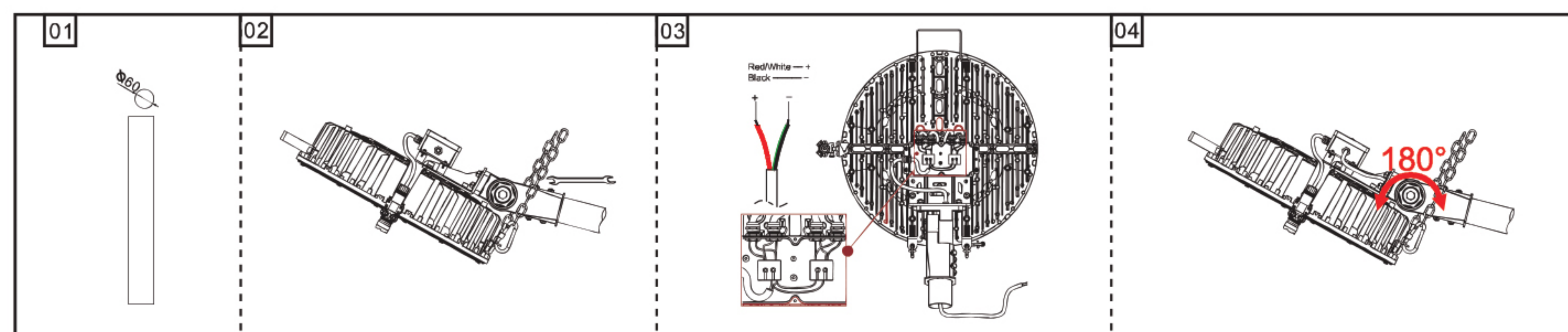
P3 Slip Fitter



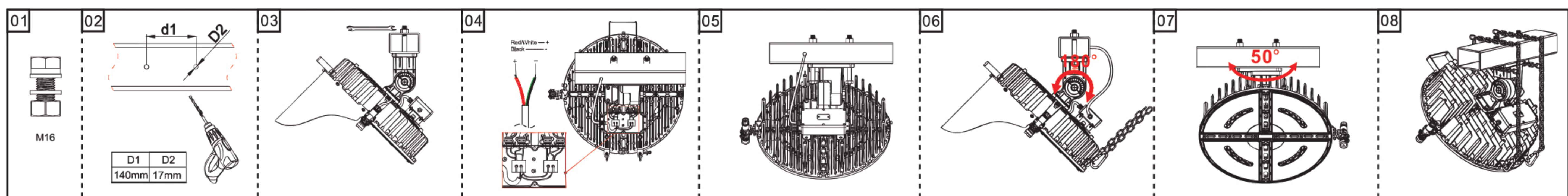
P4 Pole Bracket
