In accordance with LSA R.S. 38:2212(l), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 

Biobor Fuel Additives – Specification & Product Description

Diesel Biocide – **Biobor JF** or other dual phase biocide adhering to MIL-S 53021A and suitable for use in all hydrocarbon fuels including jet fuel. Biocide should be composed of $\geq 95\%$ active ingredients, meet EPA sulfur requirements for ULSD and provide improved lubricity properties for ULSD. Product should be applied at a maintenance treat rate of 135 ppm or a “shock” treatment of 270 ppm.

Diesel Conditioner – **Biobor DC+Cetane Summer Blend** or similar diesel conditioner applied at treat of 1:2,000 (additive:diesel).

Diesel conditioner should include the following components:

1. Cetane Improver - increasing cetane number up to 4 points
2. Concentrated detergent package – cleaning injectors, fuel pumps and other fuel system components
3. Water dispersant – prevents water accumulation inhibiting microbial growth
4. Corrosion Inhibitor – protects engine & fuel system components from pre-mature wear
5. Stabilizer – contains an ashless thermal stability additive to prevent fuel degradation for long term storage
6. Lubricity improver – decreases wear on fuel pumps and other tight tolerance components
