The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. 

Section 1.0 – Site Visit:

All prospective bidders can schedule a site visit by contacting Shayne Perez with the Department of General Services between 8:00 a.m. to 3:00 p.m., Monday Thru Friday. Mr. Perez can be reached at 504-736-6054.

Section 2.0 – Scope:

We extend this proposal to provide labor, materials, equipment, tools, and other incidentals necessary to remove and properly dispose of one (1) existing canopy and supply and install one (1) new aluminum canopy on the South Side of the Joseph S. Yenni Building Located at 1221 Elmwood Park Boulevard.

Section 3.0 – License Requirements:

License(s) issued by the Louisiana State Licensing Board for Contractors:

- Building Construction

Section 4.0 – Quantities/Inspections:

Bidders must inspect the site and perform their measurements to determine the proper quantity of labor and materials, and equipment required to complete this project.

Section 5.0 Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with their bid:

Failure to provide the requested information will result in the bid being deemed non-responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information

Section 6.0 - Bid Specifications:

- All materials shall be as specified new.
- All materials shall be as per all manufacturer recommendations and guidelines.
- Any concealed damage must be reported immediately to the owner.
- No work outside these specifications shall be performed without approval.

6.1 Before work begins:

- Successful bidder and an owner's representative shall inspect, document, and take photos of existing building conditions.
- Remove and properly dispose of the existing canopy and all associated materials.

6.2 Installation of canopy:

- Design, engineer, supply, and install one new aluminum canopy on the south side of the building.
- Perform any corrective work needed for footings and surfaces.
- Supply and install standard extruded aluminum gutters.
- Gutters shall be mounted with matching hardware per manufacturer recommendations.
- Supply and install standard extruded aluminum fascia sections as required to complete the installation resulting in a neat appearance.
- No dissimilar metals will be allowed on this project.
- One coat of high-build bituminous paint shall be applied.
- Color must match existing building finishes.

Section 7.0 – Material description:

7.1 Extruded, pre-engineered, soffit-style aluminum entry canopy

- Aluminum Extrusions: 6063 alloys, T-6 temper.
- Beams: Open-top aluminum tubular extrusions.
- Deck: Rigid-Roll-Lock extruded aluminum, self-flashing, and interlocking sections.
- Provide welded endplate water dams where sections terminate at other than drainage channels.
- Flashing: aluminum sheet, thickness as recommended by the manufacturer for a specific condition.

7.2 FINISHES

- Fascia/Gutter/Bents/Deck:
 - Clear Anodized: AA-M-10C-22A-31, Architectural Class II, comply with AAMA 607.1.
 - Thermo-Set Enamel: AA-C-12C-42R-1, comply with AAMA 603.
 - Fluoropolymer Coating: 70 percent PVDF resin-based fluoropolymer, AA-C-12C-42R-1, custom color selected by architect, comply with AAMA 605.
 - Two coat application.

Section 8.0 – Safety Precautions:

Safety precautions must be exercised to safeguard the welfare and safety of the people while any work is being performed.

Section 9.0 – Hours of Work:

The work to be performed shall be scheduled during regular working hours Monday thru Friday, 7:00 a.m. to 5:00 p.m.

Section 10.0 – Material and Workmanship Warranty:

All materials and workmanship shall have a one (1) year warranty in writing from the manufacturer.

A copy of all warranties shall be provided to the owner after completing the project.

All warranties shall commence at the competition of the project.

Section 11.0 – Existing Structure

Suppose the successful bidder should damage or destroy any part of a building, etc. The successful bidder shall be required to replace and restore said item to its original condition, with the same type of material, finish, and workmanship, at no additional cost to the owner.

Section 12.0 – Permits:

Bidder shall obtain any permits required by the Jefferson Parish Department of Inspection and Code Enforcement and any municipality where work is performed.

The bidder shall be responsible for the payment of these permits. All permits must be obtained before the start of any project requiring permits.

Section 13.0 – Liquidated Damages:

Commencing on the thirty-first (31) day following the notice to proceed, liquidated damages will be assessed in the amount of \$300/day.

Section 14.0 – Start of Work Conference and Notice to Proceed:

A "Start of Work Conference" shall be held between the successful bidder and the owner before any work commences.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work from the Department of General Services.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

JEFFERSON PARISH REQUIRED STANDARD INSURANCE

WORKER'S COMPENSATION INSURANCE

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

Note: If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being

rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

COMMERCIAL GENERAL LIABILITY

Shall provide limits not less than the following: \$1,000,000.00 Combined Single Limit per Occurrence for bodily injury and property damage.

COMPREHENSIVE AUTOMOBILE LIABILITY

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.
Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required if selected below. Such insurance is due upon contract execution.

OWNER'S PROTECTIVE LIABILITY

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

BUILDER'S RISK INSURANCE

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
