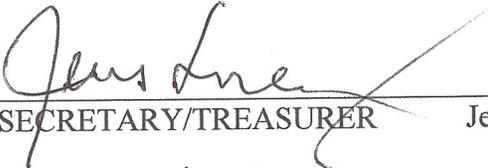
CORPORATE RESOLUTION
