Minimum Time Needed for Waterline Tie- In Operation: Once a waterline line has passed a Hydrostatic pressure test, disinfection and bacteriological testing may proceed according to the following steps with a projected minimum time line:

1. **Chlorination** - Contractor shall introduce a minimum of 25 mg/L of chlorine into waterline, which shall be retained in waterline for a minimum of 24hrs. At the end of retention period, the chlorine level must be tested, and have a residual not lower than 10 mg/L.
2. **Flushing** – The line shall be flushed for a minimum of 24hrs, or until chlorine level is reduced to a maximum 4 mg/L. When flushing is discontinued, an initial bacteriological sample can be taken.
3. **Bacteriological Testing** – Waterline shall sit for a minimum of 16hrs at which point a secondary bacteriological sample will be taken.

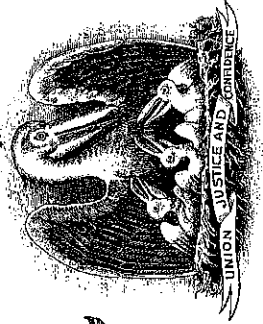

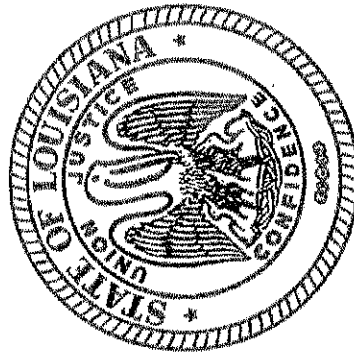
