

OCCUPANCY PROTECTION PLAN

Limited Lead Abatement and Stabilization

1617 O' Connor Street , New Orleans, Louisiana

Purpose

The lead- based paint abatement project will be performed as per all state and federal regulations.

The purpose of this Occupant Protection Plan will describe measures and management procedures that will be taken by Insulation Technologies to protect the human health and the exterior environment.

Scope of Abatement Activities

Notify DEQ 5 days prior to any Lead Mitigation

Notify City of New Orleans.

Provide exterior and interior Lead

- Mobilize on site.
- Meet with owner to coordinate and discuss activities.
- General task on this project include paint film stabilization, encapsulation, component replacement, removal, and or enclosure.
- Remove loose , flaking paint by manual hand scraping from designated substrates which includes siding, fascia, and soffit . HEPA Vacuuming techniques will be utilized.
- Remove and replace designated corner boards.
- Install Fascia.
- Roof decking. Install enclosure with similar materials.
- Application of Fiberlock LBC.
- Provide soil remediation and replacement. 2" of and install new ground covering.
- Perform PFS on designated window casings and jams
- Crawl space access- remove and replace lattice.
- Install Isolation barriers to isolate each work area utilizing polyethylene sheeting and Negative Air Machine(s) when feasible.

- Provide Hand Washing Station in an area approved by consultant and owner.
- Insulation Technologies will coordinate with owner's Project Consultant throughout project.
- All floors inside work areas will be HEPA vacuumed, wet wiped and re-HEPA vacuumed to pass clearance protocol (10 micrograms per square ft for floors and 250 micrograms per square foot on window sills).
- Care will be taken not to damage surfaces where Lead Based Paint Stabilization will take place.
- All paint chips/ flakes and debris will be stored inside 55 gal drum with proper labeling while awaiting TCLP analysis results from waste stream.
- Once project is deemed complete by owner's representative remove barriers and leave work area clean to turn back over to owner.

Insulation Technologies will take all steps to protect the existing interior and exterior finishes to avoid contamination of adjacent areas outside work areas.

- Coordinate with the owner that all loose movable items will be removed by the Owner from the affected abatement areas at a minimum of 5 feet from the work areas.
- Cover immovable objects with polyethylene sheeting if needed.
- Vertical and Horizontal surfaces will be cleaned with trisodium phosphate(TSP) and HEPA Vacuumed with an appropriate HEPA Vacuum.
- 6 mil polyethylene plastic will be placed on the ground along the perimeter of the work areas to protect surfaces.
- Warning signs will be placed at the entrance of each work area to prevent accidental entry into each work area.
- Place barrier tape around the perimeter of each work area.
- Owner's EPA ID number will be required for disposal.
- All waste storage containers will be stored on site in a safe place until pick up by LEI, Inc.

Occupant Access

The Owner/occupant will access through front entrance or back entrance during abatement during abatement activities. They will enter through the back door away from the work areas. Insulation Technologies will notify owner when work will start and be completed.

Barrier Tape and Signs will stay in place until GC's 3rd Party consultant passes each work area.

Personal Protection Equipment

It is Insulation Technologies, Inc. policy to provide personal protective equipment (PPE) as required to perform any abatement activities. Furthermore, all supervisors and workers

performing abatement are trained in the use and handling of the PPE. Our PPE will include but not limited to Tyvek suits, gloves, boots, hardhats, and eye protection. The PPE used will meet or exceed applicable OSHA Standards.






