We appreciate the opportunity to present our stormwater services. Our plans and inspection services meet all federal, state and local requirements. Listed below are the itemized quote for stormwater plans and inspections.

**1.0 COMMERCIAL SWPPP - \$1,495**

Includes production of stormwater plan and LPDES permit per the requirements of the local, state and federal requirements for stormwater compliance. The plan will include a hard-copy, sign and PDF copy. This plan will meet all requirements per specification of regulation requirements for clearing, grading and drainage/street work on the specified site. Contracts are under corporation name Baum Environmental Group, Inc. for this SWPPP and its services.

**2.0 DEQ PERMIT- \$300**

Will process DEQ permit with hand-delivery at DEQ office and pay fee on behalf of contractor. This permit will be for **one year only**. Additional years can be purchased as required at a later date.

**3.0 REMOTE INSPECTIONS – \$35/WEEK (billed monthly)**

This is weekly inspections performed by the site superintendent via photos sent to us. We will need at least 4 new photos per week along with a brief description of site progress to create reports. This will cover all compliance measures and insures no violations at the site if following with corrective actions. This is billed monthly and is suspended once the contractor is completed with his work. This is emailed to the client weekly. Failure to submit weekly site photos 2 weeks in a row will result in termination of Baum Environmental Group, Inc. performing inspections.
