The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. LABOR & MATERIALS TO REPAIR A DECORATIVE SIGN IN GRAND ISLE, LA

Section 1.0 – Pre-Bid Conference:

There will be no pre-bid conference for this bid.

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, freight and necessary essentials to repair an existing sign located along LA 1 in Grand Isle, Louisiana. Approximate GPS coordinates: 29.190523, -90.080825. This bid only covers work related to the decorative sign. No electrical work, landscape or site work is required.

Section 3.0 – Existing Site:

The site is readily accessible within the right-of-way of LA 1. The Contractor shall be responsible for any signals, barricades, signage and traffic control needed to perform his work. The Contractor shall be responsible for all tools, labor and equipment to remove and reinstall the designated portions of the sign to be repaired. While no site work is required for this bid, the Contractor shall take precaution as to not damage the site when performing his work. Any site damage resulting from the Contractor's work shall be repaired at the Contractor's expense.

Section 4.0 – Bid Specifications:

Refer to the attached images and specifications for a description of the required work.

Section 5.0 - Hours of Work:

Work may be performed at any time. The Contractor shall provide the Jefferson Parish Parkways Department with a minimum of seventy two (72) hours' notice prior to the start of work. Once the installation is complete, the Contractor shall contact the Jefferson Parish Parkways Department to schedule a final inspection of the work.

Section 6.0 – Contract Time:

The Contractor shall have ninety (90) calendar days from the date of the Notice to proceed to complete the work. There shall be no allowance of rain days with this contract.

Section 7.0 – Cleaning Area and Safety:

The job site must be clean and free of all litter and debris related to this project each time the Contractor leaves the site. At his discretion, the Contractor shall fence off his work when he is not on site working if any dangerous conditions are present.

Equipment and/or material storage shall not be permitted on site. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Warranty:

The Contractor shall warrant his materials and workmanship for a period of one (1) year after final acceptance of the project.

Section 9.0 – Pre-Construction Conference and Notice to Proceed:

A Pre-Construction Conference will not be necessary for this project. The Contractor shall provide the Jefferson Parish Parkways Department with a minimum seventy-two (72) hour notice of when work will begin. A Jefferson Parish Parkways Department employee will meet the Contractor at the site to answer any questions. No work shall be performed until the successful bidder receives a written "Notice to Proceed" or "Purchase Order" from the Jefferson Parish.

Specifications, Images and Notes:



The above image represents the original sign after installation on or about 2009.

Note: Due to previous repairs, the existing 'fish' colors differ from the colors shown in the above image.

The following is a list of components that make up the sign:

- Lettering to spell out 'Grand Isle' is fabricated from 3/8" thick grade 304 stainless steel. Lettering height is approximately 3'-0". Lettering includes fabricated gussets and base plates. Lettering is attached to the concrete foundation with anchor bolts.
- The three 'walls' behind the lettering are fabricated from 3/16" thick grade 304 stainless steel. The walls vary in height and are contoured to create a 'rolling' effect. Each wall panel is approximately 11'-6" in length and average about 4'-6" in height. Wall include fabricated gussets and base plates. Walls are attached to

the concrete foundation with anchor bolts. The wave walls have a translucent blue marine grade powder coat finish.

- The three 'fish' sculptures are constructed of A588 weathering steel that are epoxy primed with a marine grade powder coat finish.
- Approximate 'fish' lengths (left to right): 7'-6", 8'-9" and 13'-3".
- The mounting poles for the 'fish' sculptures are 3" diameter schedule 40 hot dipped galvanized poles with fabricated gussets, base plates and mounting brackets for each sculpture and 'wave'.
- The poles are epoxy primed with a marine grade powder coat finish.
- Approximate pole heights (left to right): 9', 10' and 12'.
- Poles are attached to the concrete foundation with anchor bolts.
- The sculpture poles include 'waves' fabricated from 3/8" thick grade 304 stainless steel.
- There are seven (7) 'waves' ranging in size from approximately 3'-0" to approximately 7'-0" in length.

Required Lettering Work:

1. The Contractor shall remove the letter 'I' from the existing concrete foundation. This letter was bent due to one of the walls falling on top of it. *See Images 1 & 2.*
2. The Contractor shall make every effort possible to protect reuse the existing anchor bolts.
3. The letter shall be removed and reformed so that it is flat and plumb in relation to the existing concrete foundation.
4. The Contractor shall reinstall the letter utilizing the existing anchor bolts.
5. In the event that the existing anchor bolts cannot be reused, the Contractor shall adjust the bolt pattern so that the letter may be reinstalled in the exact same position from where it was removed.

Required Wall Work:

1. The Contractor shall remove all three of the walls located behind the lettering.
See Image 3.
2. The Contractor shall grind all existing anchor bolts to be flush with the surface of the existing concrete foundation.
3. Each wall shall be sand blasted and then reformed to remove any bends in the stainless steel.
4. As needed, the Contractor shall grind any deep scratches or dents in an effort to create a smooth surface on all sides. *See Image 4.*
5. The Contractor shall repair, as needed, the gussets and mounting plates so that the walls can be reinstalled with the wall face plumb in relation to the existing concrete foundation. *See Image 5.*
6. The Contractor shall have all walls, gussets and mounting plates finished with an epoxy primer and marine grade powder coat finish with a similar color to the existing walls.
7. The walls shall be reinstalled onto the existing concrete foundation utilizing new anchor bolts of the same diameter of the existing bolts. A total of (18) bolts are required. The minimum bolt length shall be 8".
8. The walls shall be installed as close to the original location on the concrete foundation as possible.

Required 'Fish' Sculpture Work:

1. The Contractor shall remove all three of the 'fish' sculptures located behind the walls. *See Images 6, 7 & 8.*
2. Each fish sculpture shall be removed from the mounting pole and then sand blasted to remove all existing paint.
3. Each fish sculpture shall then be epoxy primed and then receive a marine grade powder coat finish with similar colors to the existing 'fish'.
4. The three (3) existing poles shall be replaced with new 3" diameter schedule 40 posts with heights matching the existing poles. Poles shall be hot dipped galvanized and shall receive an epoxy primer and marine grade powder coat finish with a similar color to the existing poles.
5. All gussets and base plates shall be equal to, or greater than, existing gussets and base plates.
6. The Contractor shall salvage all existing stainless steel 'waves' and then reattach to the new poles in a similar method as existing. *See Image 9.*
9. All 'fish' and poles shall be reinstalled onto the existing concrete foundation utilizing new anchor bolts of the same diameter of the existing bolts. A total of (12) bolts are required. The minimum bolt length shall be 8".
10. The 'fish' and poles shall be installed as close to the original location on the concrete foundation as possible.



the program, but who has been certified by the Office of Apprenticeship Training, Employer and Labor Services or a State Apprenticeship Agency (where appropriate) to be eligible for probationary employment as an apprentice. The allowable ratio of apprentices to journeymen on the job site in any craft classification shall not be greater than the ratio permitted to the contractor as to the entire work force under the registered program. Any worker listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated above, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. CONTRACT WORK HOURS AND SAFETY STANDARDS ACT

Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (b)(1) of this paragraph, in the sum of \$27 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of forty (40) hours without payment of the overtime wages required by the clause set forth in paragraph (b)(1) of this section.

(3) Withholding for unpaid wages and liquidated damages. The federal agency and/or Jefferson Parish shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contract, or any other Federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or

(b) Allocation of Principal Rights

The disclosure shall also identify any publication, on sale or public use of the invention and whether a manuscript describing the invention has been submitted for publication and, if so, whether it has been accepted for publication at the time of disclosure. In addition, after disclosure to the *agency*, the *Contractor* will promptly notify the *agency* of the acceptance of any manuscript describing the invention for publication or of any on sale or public use planned by the *contractor*.

(2) The *Contractor* will elect in writing whether or not to retain title to any such invention by notifying the *Federal agency* within two years of disclosure to the *Federal agency*. 




