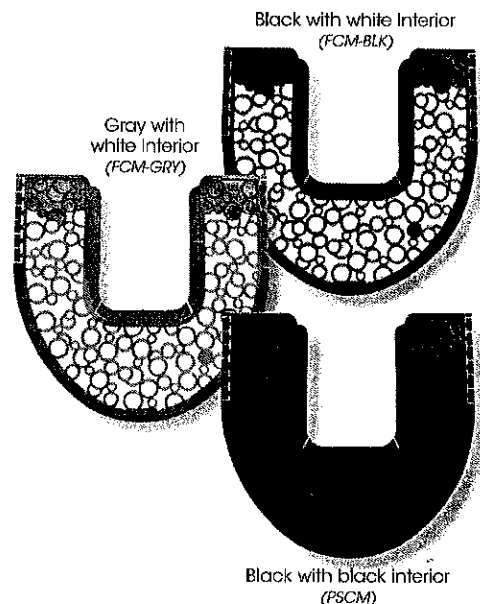
Absorption comparison after 2 weeks


