

1. Mill over height areas.
2. Clean areas of all loose rock, dirt, trash, vegetation.
3. Tack with SS-I
4. Overlay with 1.5" wearing type asphalt.
5. Compact with 6-ton steel wheel roller.
6. Area approximately 2000 square feet

B. Parking Lot Repairs.

1. Clean area of all loose rock, dirt, trash and vegetation.
2. Tack with SS-I
3. Level low areas with full depth asphalt.
4. Compact with 6-ton steel wheel roller.
5. 12 areas totaling 4,643 square feet.
6. Restripe areas of repair.
