By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. Vendor to provide parts, labor, equipment, and materials to remove and replace the existing roll up door at the Eastbank Wastewater Treatment Plant grit garage located at #2 Humane Way, Harahan, LA 70123.

DOOR

GENERAL

ASTA Door Corporation

Service Door (22 Gauge) Model no. 422, or approved equal.

TYPE: Standard Rolling Steel Flat Slat Door, as manufactured by Asta Door Corporation.

12 feet wide X 12 feet, 4 inches high, 22 Gauge – 3-Piece structural steel; flat slats

Guides – factory installed baffle in hood and weather stripping on guides.

Left hand drive.

Cold Galvanized Headplates, guides, and bottom bar.

Color – Grey

Windload – door must be designed to meet or exceed a windload of 20 PSF or 90 M.P.H.

OPERATION: To be chain hoist operated using gear reduction.

MOUNTING: To be interior face mounted on a prepared opening.

CURTAIN

Slats

22 Gauge galvanized steel cold roll formed in continuous lengths. Galvanized according to A.S.T.M. A653-G90 and finished with baked epoxy primer and baked polyester top coat.

End Locks

Each end of alternate slats to be fitted with endlocks to provide a wearing surface in the guides and to maintain slat alignment. Fastened with ¼ inch rivets.

Bottom Bar

Curtain to be reinforced with a bottom bar consisting of two 2 inch x 2 inch x 1/8 inch structural steel angles with P.V.C. bulb astragal.

BARREL ASSEMBLY

Barrel to be a steel pipe of diameter and wall thickness to restrict maximum deflection to .03 inch per foot (2.5mm/m) of door width.

Springs to be oil tempered, grease packed helical torsion type designed to cycle 20,000 times with an overload factor of 25%. Springs are to be mounted on a cold rolled steel inner shaft.

End Bearing to be self-lubricating ball bearings or oil impregnated bronze bushings.

BRACKET PLATES

Bracket Plates to be 1/4 inch (6.35mm) minimum thickness steel plate and enclose ends of barrel assembly.

Drive End Bracket Plate to be fitted with a self-aligning sealed ball bearing.

Operation

Drive to consist of roller chains and sprockets.

Hand Chain to be galvanized machine link. Pull not to exceed 35 pounds.

Guide Assembly

Wall Angles – to be 3/16 inch (4.76mm) minimum thickness structural steel angles.

Guides - To be structural steel angles 3/16 inch (4.76mm) minimum thickness with removable headstops.

Guide Depth - to provide slat penetration adequate to satisfy specified windloading.

HOODS

Hoods – to be 24 gauge galvanized steel with baked epoxy primer and/or baked polyester top coat and enclose coil.

Locking

Hand Chain Lock – lockable bracket, mounted on guide angle or wall, suitable for padlocking (padlock by others).

Finish

Finish - grey

Ungalvanized Surfaces - to be shop coated with rust reducing black prime paint, except malleable endlocks.

To be installed according to manufacturer's standards and instructions.

Floor level disconnect and Chain Hoist with electrical interlock for hoist operation in an emergency. Left hand headplate mount; ½ HP; 208/230/460 Vac; Three phase; 60Hz; Open/Close/Stop 3-button Control Station. Heavy-Duty 11 gauge steel frame with durable powder coated finish. Solenoid brake.

MOTOR – Continuous duty high-starting torque motor; Commercial protector system auto reverses the door if entrapment protection device detects an obstruction.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability, Workmen's Compensation Insurance and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

JEFFERSON PARISH REQUIRED STANDARD INSURANCE

☐ WORKER'S COMPENSATION INSURANCE

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

Note: If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being

rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

☐ **COMMERCIAL GENERAL LIABILITY**

Shall provide limits not less than the following: \$1,000,000.00 Combined Single Limit per Occurrence for bodily injury and property damage.

☐ **COMPREHENSIVE AUTOMOBILE LIABILITY**

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.
Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

DEDUCTIBLES - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

UMBRELLA LIABILITY COVERAGE

An umbrella policy or excess may be used to meet minimum requirements.

FOR CONSTRUCTION AND RENOVATION PROJECTS:

The following are required unless otherwise specified in the bid. Such insurance is due upon contract execution.

1) **OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

2) **BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
