## DETAILED SPECIFICATIONS FOR MOSQUITO CONTROL CHEMICALS

### ARTICLE 1 - SCOPE OF WORK

Furnish, deliver, and unload F.O.B. to the Vermilion Parish Police Jury, Public Works Building, 2211 Leonie Street, Abbeville, Louisiana, the following mosquito control chemicals.

### ARTICLE 2 - MOSQUITO CONTROL CHEMICALS

Chemicals shall meet all EPA specifications for Ground Mosquito Control Applications by Ground ULV Machines and Aerial Applications. They shall also meet all label requirements of the EPA. **MSDS sheet and product label must accompany bid.**

#### **MALATHION**

Chemical containing 96.8-percent technical grade 9.79-pounds per gallon approved label for ultra low volume application for mosquito control. Product must have an Oral LD<sub>50</sub> (rat) of 5,550-mg/kg. Price quoted should be per gallon and should not include taxes. Prices are to be quoted by the gallon. Chemicals shall be supplied in bulk transport (55-gallon drum not acceptable). Vermilion Parish Police Jury to furnish appropriate tanks, 1,000-gallon minimum.

#### **DIBROM CONCENTRATE**

A special formulation for use undiluted or diluted in diesel oil. Chemical containing 87.4-percent Naled and 12.6-percent other ingredients. Product must have an Oral LD<sub>50</sub> (rat) of 92/191 mg/kg (male/female). Prices are to be quoted per gallon, not including taxes.

#### **SCOURGE INSECTICIDE**

A synthetic pyrethroid formulation. Chemical containing 18-percent Resmethrin, 54-percent Piperonyl Butoxide - Technical, and 28-percent other ingredients. Prices are to be quoted per gallon, not including taxes.

#### **SYNERGIZED PERMETHRIN**

31-66: A synergized concentrate of permethrin containing a minimum 31-percent of Permethrin and a minimum 66-percent of Piperonyl Butoxide - technical (or 31-67). Product must have an Oral LD<sub>50</sub> (rat) of >500-mg/kg.

31-67: 31.15%: Permethrin. Piperonyl Butoxide Technical: 66.85%. Inert Ingredients: 2.0%.

Prices are to be quoted per gallon, not including taxes.

#### **SUSPEND SC INSECTICIDE**

Chemical containing 4.75-percent Deltamethrin and 95.25-percent other ingredients. Prices are to be quoted per gallon, not including taxes.

**ALTOSID BRIQUETS**

Chemical containing 8.62-percent S-Methoprene (CAS #65733-16-6) (Dry Weight Basis) and 91.38-percent other ingredients. Prices are to be quoted per case, not including taxes.

**VECTOLEX WDG**

Chemical containing 51.2-percent w/w Bacillus sphaericus serotype H5a5b, Strain 2362 dried concentrate and 48.8-percent w/w Inert ingredients. Prices are to be quoted per pound, not including taxes.

**DUET**

Chemical containing 1.00-percent Prallethrin, 5.00-percent Sumithrin, 5.00-percent Piperonyl Butoxide, and 89.00-percent Other Ingredients. Prices are to be quoted per gallon, not including taxes.

**ULV MOSQUITO MASTER 412**

Chemical containing 12.0-percent Chlorpyrifos [0.0-diethyl 0-(3,5,6, -trichloro 2-pyridyl)] phosphorothioate, 4.0-percent Permethrin (3-phenoxyphenyl) methyl ( $\pm$ ) cis, trans-3-(2,2-dichlorethenyl) -2,2-dimethyl-cyclopropanecarboxylate, and 84.0-percent other ingredients. **DELTAGARD INSECTICIDE**

**AQUA ANVIL**

Contains 10.0-percent Sumithrin, 3-Phenoxybenzyl-(1RS, 3RS, 1RS, 3SR)-2,2-dimethyl-3-(2-methylprop-1-enyl) cyclopropanecarboxylate; 10.0-percent Piperonyl Butoxide (butylcarbityl)(6-propylpiperonyl) ether and related compounds; and 80.0-percent other ingredients. For ground and aerial applications. Ready to use solution. Prices are to be quoted per gallon, not including taxes.



- Not for use in outdoor residential misting systems.
- Do not make applications during rain.
- Do not spray this product on or allow it to drift onto cropland (other than crops listed), or potable water supplies.
- In the treatment of corrals, feedlots, animal confinements/houses, swine lots, poultry ranges and zoos, cover any exposed drinking water, drinking fountains and animal feed before application.

Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using laser based equipment must be used to produce acceptable droplet spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

**Aerial Application made at  $\leq 200$  feet above ground elevation:** Spray equipment must be adjusted so that the volume median diameter produced is less than 60 microns ( $D_{v0.5} < 60 \mu\text{m}$ ) and that 90% of the spray is contained in droplets smaller than 100 microns ( $D_{v0.9} < 100 \mu\text{m}$ ). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

**Aerial Application made at > 200 feet above ground elevation:** Spray equipment must be adjusted so that the volume median diameter produced is less than 70 microns ( $D_{V0.5} < 70 \mu\text{m}$ ) and that 90% of the spray is contained in droplets smaller than 145 microns ( $D_{V0.9} < 145 \mu\text{m}$ ). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

## GROUND BASED APPLICATIONS

**ULV NON-THERMAL AEROSOL (COLD FOG):** To control Mosquitoes, Midges and Black flies, apply PERM-X™ UL 31-66 using truck-mounted ground ULV (cold fog) equipment. When applying this product undiluted, apply at a flow rate of 0.4794 to 1.91183 fluid ounces per minute at an average speed of 10 mph. These rates are equivalent to 0.00175 to 0.007 pounds of permethrin a.i. and 0.0038 to 0.0149 pounds of piperonyl butoxide a.i. per acre. If a different vehicle speed is used, adjust the rate accordingly. Vary flow rates accordingly to vegetation density and mosquito population. Use higher flow rates in heavy vegetation or when insect populations are high. An accurate flow rate control system must be used to ensure proper flow rate. PERM-X™ UL 31-66 may also be applied by diluting, 1 part to 1 part of a 60 to 100 second mineral oil or another suitable solvent, applied so as not to exceed the maximum a.i. rates per acre as shown in the rates charts. If an alternate dilution rate is required, adjust the flow rate accordingly, provided the droplet size and spectrum remain within label specifications. Do not exceed a flow rate of 20 oz/minute unless recommended and required by equipment manufacturers and/or Public Health Officials for vehicle speeds of 10 to 20 mph and when the fogging equipment is capable of such higher rates of output per minute.

**THERMAL FOGGING:** Apply PERM-X™ UL 31-66 diluted or by suitable Thermal Foggers mounted on trucks. If diluted, use a 60 to 100 second viscosity mineral oil, or another suitable non-phytotoxic diluent to reduce oil requirement and sludge buildup in equipment. for fixed wing aircraft with flat fan nozzles is from 120 to 160 mph. For aircraft equipped with rotary nozzles, apply at sufficient airspeed to deliver the appropriate amount of PERM-X™ UL 31-66 a.i. per acre. Before administering pralidoxime chloride, obtain a blood sample for cholinesterase analysis. Adjusting for age and weight, pralidoxime may be administered as a continuous infusion after a loading dose or using a bolus method. Clear airway and provide oxygen before administering atropine. Give atropine intramuscularly or intravenously, depending on severity of poisoning. Atropine may be administered through an alternative route such as an endotracheal tube. The dosage for atropine is as follows: 1 to 2 mg/kg initially IV in adults (or 0.05 mg/kg in children under 12 years) then give appropriate doses every 5 minutes until excessive secretions and sweating have been controlled. Use soap (preferably Tincture Green Soap) and water or dilute hypochlorite solution for decontaminating skin. Avoid opiates, parasympathomimetic agents (e.g. succinylcholine), theophylline, reserpine and or phenothiazines. Suction oral secretions and emesis to avoid aspiration. Artificial respiration or oxygen administration may be necessary. A slurry of activated charcoal may be medically warranted at an oral dose appropriate for adult, child or infant.
